EXHIBIT "A" LEGAL DESCRIPTION OF PROPERTY

That part of Lots 4 and 5 in Block 5 in Boeger Estates Addition to Roselle, being a subdivision of the South Half of the Southwest Quarter of Section 34, Township 41 North, Range 10 East of the Third Principal Meridian, in Cook County, Illinois; described as follows:
