1. *Chloris* (L.) *virginica* L. (Fig. 1). - A slender annual grass, 1-2 m. tall, with long, narrow, linear leaves, 1-2 mm. wide, and numerous panicles, each bearing 1-2 spikelets. The spikelets are 1-2 cm. long, 2-3 mm. broad, and have 3-5 lemmas. The awns are 1-2 cm. long, straight, and barbed at the tip. The culms are 1-2 m. tall, 1-2 mm. thick, and have a few long, narrow, linear leaves. The panicles are 1-2 cm. long, 2-3 mm. broad, and have 3-5 lemmas. The awns are 1-2 cm. long, straight, and barbed at the tip.
