NOTICE IS HEREBY GIVEN that the Village of Palatine, Cook County, Illinois, claims a lien in the amount of \$2322.56 on the property hereinafter described pursuant to Section 19-3 of the Palatine Village Code for unpaid bills for water (or sewer) services on property commonly known as 2322 W. 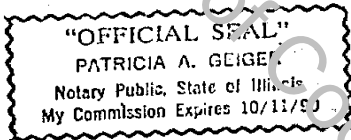
