



EXHIBIT "A"

LEGAL DESCRIPTION:

That part of the North 60 feet of Lot 3 in Block "A" in Concord Terrace, being a subdivision in the Northwest Quarter of the Southeast Quarter of Section 34, Township 41 North, Range 10 East of the Third Principal Meridian, in Cook County, Illinois; described as follows:
