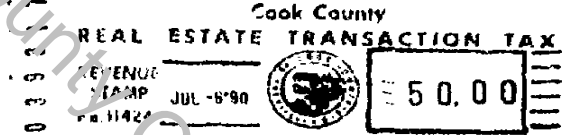
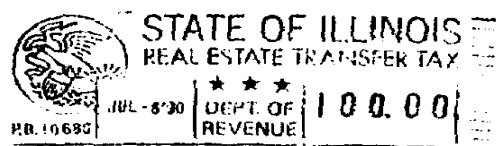
This Indenture, Made this 28th day of June 19 90

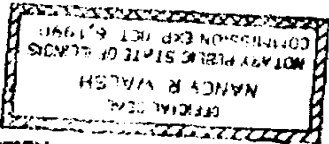
