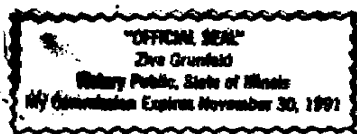

## EXHIBIT "A"

That part of Lots 7 and 8 in the Subdivision of Lots 18 to 24 inclusive and a strip of land 20 feet wide lying East of and adjoining said lots in Block 38 of Rogers Park in Section 31, Township 41 North, Range 14 East of the Third Principal Meridian, described as follows:  
Beginning at the South West corner of Lot 8 aforesaid; thence Northwestery on the Westerly line of said Lot, 56 feet; thence Easterly on a line making an angle of 90 degrees with said Westerly line, 44 feet; thence Northwestery 31 feet, to a point 29 feet 4 inches West of the Easterly Line of said Lot 7 aforesaid; thence Easterly 29 feet 4 inches to a point on the Easterly line of said Lot 7, which is 86 feet South of the North East corner thereof; thence Southeastery along said Easterly line 87 feet 1 1/4 inches to the South East corner of said Lot 7; thence West 100 feet 1 5/8 inches along the South line of Lots 7 and 8 to the point of beginning, in Cook County, Illinois.
