LEGAL DESCRIPTION

PARCEL 1: Beginning 122 feet North of the Southeast corner of a parcel of land described as the North 3.768 acres of that part of the Northwest 1/4 of Section 9, Township 36 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois, lying Easterly of the Wabash, St. Louis and Pacific Railroad, thence North 50 feet thence West 158 feet; thence South 50 feet; thence East 158 feet to the place of beginning, in Cook County, Illinois.

PARCEL 2: The South 172 feet (except the South 71 feet thereof) and (except the East 158 feet thereof) of the North 3.768 acres of that part of the Northwest 1/4 of Section 9, Township 36 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois, lying Southeasterly of the Wabash, St. Louis and Pacific Railroad, in Cook County, Illinois.
