NOW. THEREFORE, Mortansor to secure the payment of said crinerpal sum of money and said interest in accordance with the terms, provisions and limitations of this mortage, and of the mortage note secured hereby, and the performance of the covenants and agreements herein contained, by Mortagor to be performed, and also in consideration of the sum of One Pollar (\$1.00) in hand paid, the receipt whereof is hereby acknowledged, does by these presents MOPTGAGE, CONVEY and WARRANT unto Mortagee, its successors and assigns, the following described real estate and all of its relate, right, title and interest therein, lying and being in the City of Chicago, County of Cook and State of Illinois, to wit:

which is commonly known as 1944 West Superior, Chicago, Illinois and which, with the property hereinafter described, is referred to herein as the "premiser".

TOGETHER with all improvements, tengments. easements. fixtures, and appurtenances thereto belonging, and all rents. issues and profits thereof for so long and during all such times as Morteagor may be entitled thereto (which are placed primarily and on parity with said real estate and not secondar ly), and all shades, awnings, venetian binds, screens, screen jors, storm doors and windows, stoves and ranges, curtain fixtures, partitions, attached floor covering, now or hereafter herein or thereon and all fixtures, apparatus, equipment or articles now or hereafter therein or thereon used to supply heat, gas, air conditioning, water, light, power, sprinkler protection, waste removal, refrigeration (whether single units or centrally controlled), and ventilation; it being understood that the enumeration of any specific articles of property shall in no wise exclude or be held to exclude any stems of property not specifically mentioned. All of the lane, estate and property hereinshove described, real, personal and mixed, whether affixed or annexed or not (except when otherwise hereinnhove specified) and all rights hereby conveyed and mortgaged are intended so to be as a unit and are hereby understood, agreed and declared to form a part and parcel of the real estate and to be appropriated to the use of the real estate, and shall for the purposes of this mortgage be deemed to be real estate and conveyed and mortgaged Incorrection.

TO HAVE AND TO HOLD the premises unto the said Mortgagee, its successors and assigns, forever, for the purposes and uses herein set forth.

IT IS FURTHER UNDERSTOOD AND AGREED THAT:

MAINTENANCE, REPAIR AND RESTORATION OF IMPROVEMENTS, PAYMENT OF PRIOR LIENS, ETC.

1. Mortgagor shall (a) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (b) keep said premises in good condition and repair, without waste, and free from mechanics' liens or other liens or claims for lien not expressly subordinated to the lien hereof; (c) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Mortgager; (d) complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (e) comply with all requirements of law, municipal ordinances, in restrictions of record with respect to the premises and the use thereof, (f) make no material alterations in said premises except as required by law or municipal ordinance; (g) suffer or permit no change in the general nature of the occupancy of the oremises, without Mortgagee written consent; (h) initiate or acquiesce in no zoning reclassification, without Mortgagee's written consent; (i) pay each item of indebtedness secured by this mortgage when due according to the terms hereof or of the note.

PAYMENT OF TAXES

2. Mortgagor shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Mortgagee duplicate receipts therefor. To prevent default hereunder Mortgagor shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagor may desire to contest.

INSURANCE

3. Mortgagor shall keep all buildings and improvements or hereafter situated on said premises insured against loss or damage by fire and such other hazards as may reasonably be required by Mortgagee. Mortgagor shall also provide liability insurance with such limits for personal injury and death and property damage as Mortgagee may reasonably require. All policies of insurance to be furnished hereunder sier's be) r) forms, from companies and in amounts reasonably satisfactory Mortgagee, with mortgagee clauses attached to all policles in favor of and in form satisfactory to Mortgagee, including a provision requiring that the coverage evidenced thereby shall not he terminated or materially modified without ten (10) days prior written notice to Mortgagee. Mortgagor shall deliver policies, including additional and renewal policies to Mortgagee. and, in the case of insurance about to expire, shall deliver renewal policies not less than ten (10) days prior to their respective dates of expiration.

In addition, Mortgagee shall have the right, in its sole discretion, to require the establishment of an escrow at Mortgagee for the payment of all items listed in this paragraph and paragraph 2, above.

ADJUSTMENT OF LOSSES WITH INSURER AND APPLICATION OF PROCEEDS $||\phi F||$ INSURANCE

In case of loss, Mortgagee for after entry of decree foreclosure, purchaser at the sale, or the decree creditor, the case may be) is hereby authorized either (a) to settle adjust any claim under such insurance policies without consent of Mortgagor, or (b) to allow Mortgagor to agree with the insurance company or companies on the amount to be paid upon the loss. either case Mortgagee is authorized to collect and receipt any such insurance money. If the insurers do not deny liability as to the insureds, such proceeds, after deducting therefrom any expenses incurred in the collection thereof, shall be used reimburse Mortgagor for the cost of rebuilding or restoration buildings and improvements on said premises. In all other cases, such insurance proceeds may, at the option of Mortgagee, be applied in reduction of the indebtedness secured hereby, whether due or not, or be held by Mortgagee and used to reimburse Mortgager for the cost of the rebuilding or restoration of buildings or improvements on said premises. The buildings and The buildings and improvements shall be so restored or rebuilt as to be of at least equal value and substantially the same character as prior to such damage or destruction. In the event Mortgagor is entitled to reimbursement out of insurance proceeds, such proceeds shall be made available, from time to time, upon Mortgagee being furnished with satisfactor, evidence of the estimated cost of completion thereof and with such architect's certificates, waivers of lien, contractor's sworn of Rements and other evidence of cost and of payments as Mortgagee may reasonably require and approve, and if the estimated cost of the work exceeds ten percent (10%) of the original principal amount of the indebtedness secured hereby, with all plans and specifications for such rebuilding or restoration as Mortgagee may reasonable require and approve. No payment made prior to the inal completion of the work shall exceed ninety percent (90%) of the value of the work performed, from time to time, and at all times the undisbursed balance of coild proceeds remaining in the bands of Mortgagee shall be at said proceeds remaining in the hands of Mortgagee shall be at least sufficient to pay for the cost of the work free and clear least sufficient to pay for the of liens.

In case of loss after foreclosure proceedings have been the proceeds of any such insurance policy policies, if not applied as aforesaid in rebuilding or restoring the buildings or improvements, shall be used to pay the amount due in accordance with any decree of forcelosure that may be entered in any such proceedings, and the balence, if any, shall be paid to the owner of the equity of redemption if he shall then be entitled to the same or as the court may direct. In case of the foreclosure of this mortgage, the court in lite decree may provide that the mortgagee's clause attached to each of said insurance policies may be cancelled and that the decree creditor insurance policies may be cancelled and that the decree creditor may cause a new loss clause to be attached to each of said policies making the loss thereunder payable to said decree creditor; and any such foreclosure decree may further provide, that in case of one or more redemptions under said decree. pursuant to the statute in such case made and provided, then in every such case, each successive redemptor may cause the proceeding loss clause attached to each insurance policy to be cancelled and a new loss clause to be attached thereto, making the loss thereunder payable to such redemptor. In the event of foreclosure sale, Mortgagee is hereby authorized, without the consent of Mortgagor, to assign any and all insurance policies to the purchaser at the sale, or to take such other steps as Mortgagee may deem advisable, to cause the interest of such purchaser to be protected by any of the said insurance policies.

STAMP TAX

5. If, by the laws of the United States of America, or of any state having jurisdiction over Morizagor, any tax is due or becomes due in respect of the issuance of the note hereby secured, Mortgagor covenants and agrees to pay such tax in the manner required by any such law. Mortgagor further covenants to hold harmless and agrees to indemnify Mortgagee, its successor or assigns, against any liability incurred by reason of the imposition of any tax on the issuance of the note secured hereby.

FUTURE ADVANCES

by Mortgagee under any subsequent agreement unless otherwise provided herein. All such advances made shall be secured hereby and shall have and be entitled to the same lien priority as that indebtedness first extended to Mortgagor by Mortgagee under the Mortgage Note. All future advances shall be made under the terms of this rote or new notes and in no event shall be made after twenty years from the date hereof.

PREPAYMENT UPIVILEGE

7. At such time as Mortgagor is not in default either under the terms of the note secured hereby or under the terms of this mortgage, Mortgagor shall have the privilege of making prepayments on the principal of said note (in addition to the required payments) in accordance with the terms and conditions, if any, set forth in said note.

OBSERVANCE OF LEASE ASSIGNMENT

8. In the event Mortweter, as additional security for the payment of the indebtedness described in and secured hereby, has sold, transferred and assigned, or may hereafter sell, transfer and assign, to Mortgagee, his successors and assigns, any interest of Mortgagor as lessor is any lease or leases, Mortgagor expressly covenants and agrees that if Mortgagor, as lessor under such lease or leases assigned, shall fell to perform and fulfill any term, covenant, condition or profision in said lease or leases, or any of them, on its part to be performed or fulfilled, at the times and in the manner in said lease or leases provided, or if Mortgagor shall suffer or permit to occur any breach or default under the provisions of any assignment of any lease or leases of the premises given as additional security for the payment of the indebtedness secured hereby and such default shall continue for three (3) days, then and in any such event, such breach or default shall constitute a default hereunder.

EFFECT OF EXTENSIONS OF TIME.

9. If the payment of said indebtedness or any part, thereof be extended or varied or if any part of the security be re-rased, all persons now or at any time hereafter liable therefor, or interested in said premises, shall be held to assent to such extension, variation or release, and their liability and the lien and all provisions hereof shall continue in full force, the right of recourse against all such persons being expressly reserved by Mortgagee, notwithstanding such extension, variation or release.

EFFECT OF CHANGES IN LAWS REGARDING TAXATION

10. In the event of the enactment after this date of any law of the state in which the premises are located deducting from the value of land for the purpose of taxation any lien thereon, or imposing upon Mortgagee the payment of the whole or any part of

the taxes or assessments or charges or liens herein required to be paid by Mortgagor, or changing in any way the laws relating to the taxation of mortgages or debts secured by mortgages or the mortgagee's interest in the property, or the manner of collection of taxes, so as to affect this mortgage or the debt secured hereby or the holder thereof, then, and in any such event, Mortgagor, upon demand by Mortgagee, shall pay such taxes or assessments, or reimburse Mortgagee therefor; provided, however, that if in the opinion of counsel for Mortgagee (a) it might be unlawful to require Mortgagor to make such payment or (b) the making of such payment might result in the imposition of interest beyond the maximum amount permitted by law, then and in such event, Mortgagee may elect, by notice in writing given to Mortgagor, to declare all of the indebtedness secured hereby to be and become due and payable sixty (60) days from the giving of such notice. Notwithstanding anything to the contrary contained herein, Mortgagor shall not be liable for any federal, state or local income, excess profit, franchise or capital stock taxes of Mortgagee.

MORTGAGELI'S PERFORMANCE OF DEFAULTED ACTS

II. In ase of default therein, Mortgagee may, but need not, make any payment or perform any act herein required of Mortgagor in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lier or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection transwith, including attorneys' fees, and any other moneys advanced by Mortgagee to protect the mortgaged premises and the lien hereof, shall be so much additional indebtedness secured hereby, and shall become immediately due and payable without notice and with interest thereon at a rate which is five percent (5%) in excess of the mortgage rate. Inaction of Mortgagee shall never be considered as a waiver of any right accruing to it on account of any default on the part of Mortgagor.

MORTGAGEE'S RELIANCE ON TAX BILLS, ETC.

12. Mortgagee in making payment hereby authorized: (a) relating to taxes and assessments, may do so according to any bill, statement or estimate produced from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lies or title or claim thereof; or (b) for the purchase, discharge, compromise or settlement of any other prior lies, may do so without inquiry as to the validity of amount of any claim for lies which may be asserted.

ACCELERATION OF INDEBTEDNESS IN CASE OF DEFAULT

of said notes, or any installment due in accordance with the terms thereof, either of principal or interest and such default shall not be cured within the earlier of ten (10) days following the delivery of notice thereof to Mortgagor or as otherwise provided in said notes: or (b) Mortgagor shall file a petition in voluntary bankruptcy or under Chapter 7, Chapter 11, or Chapter 13 of the Federal Bankruptcy Code or any similar law, state or federal, whether now or hereafter existing, or an answer admitting insolvency or inability to pay its debts within ten (10) days; or (c) Mortgagor shall fail to obtain a vacation or

stay of involuntary proceedings within sixty (60) days, as hereinafter provided; or (d) Mortgagor shall be adjudicated a hankrupt, or a trustee or a receiver shall be appointed for Mortgagor or for all of its property or the major part thereof in any involuntary proceeding, or any court shall have taken jurisdiction of the property for the reorganization, dissolution, liquidation or winding up of Mortgagor, and such trustee or receiver shall not be discharged or such jurisdiction relinquished or vacated or stayed on appeal or otherwise stayed within sixty (60) days; or (e) Mortgagor shall make an assignment for the benefit of creditors, or shall admit in writing inability to pay its debts generally as they become due, or shall consent to the appointment of a receiver or trustee or liquidator of all of its property or the major part thereof; or, (f) default shall be made in the due observance or performance of any other of the covenants, agreements or conditions hereinbefore or hereinafter contained, required to be kept or performed or observed by Mortgagor and the same shall continue for thirty (30) (45) drys following the delivery of notice thereof to Mortgagor, then and in every such case the whole of said principal sum hereby secured shall, at once, at the option of Mortgagee, become immediately due and payable, together with accrued interest thereon, w.t.out notice to Mortgagor.

FORECLOSURE; EXPENSE OF ALL TYPES OF LITIGATION

the indebtedness hereby secured, or any part When thereof, shall become due, whether by acceleration or otherwise, Mortgagee shall have the right to foreclose the lien hereof for such indebtedness or pero thereof. In any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or incurred by or on behalf of Mortgagee for reasonable attorneys' feet, appraiser's fees, outlays for documentary and expert evidence, stenographers' charges, publication costs, and costs (vhich may be estimated as to items to be expended after entry of the decree) of procuring all such abstracts of title, title searches and examinations, title insurance policies. Torrers certificates and cimilar data insurance policies, Torrens certificates, and similar data and assurances with respect to title as hortgagee may deem reasonably necessary either to prosecute such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of the title to or the value of the premises. All expenditures and expenses of the nature in this paragraph mentioned, and such expenses and food or the value of the premises. expenditures and expenses of the nature in this paragraph mentioned, and such expenses and fees as may be incurred in the protection of said premises and the maintenues of the lien of this mortgage, including the fees of any accorney employed by Mortgagee in any litigation or proceeding affecting this mortgage, the note or said premises, including probate, housing and building code violation, and bankruptcy proceedings, or in preparations for the commencement or defense of any proceeding or threatened suit or proceeding, shall be immediately due and payable by Mortgagor, with interest thereon at a rate which is five percent (5%) in excess of the mortgage rate and smill secured by this mortgage.

APPLICATION OF PROCEEDS OF FORECLOSURE SALE

15. The proceeds of any foreclosure sale of the premises shall be distributed and applied in the following order of priority; First, on account of all costs and expenses incident to the foreclosure proceedings, including all such items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof constitute secured indebtedness additional to that evidenced by the note, with interest thereon as herein provided; third, all principal and interest remaining unpaid on the note; fourth, any overplus to mortgagor, its successors or assigns, as their rights may appear.

REMEDIES: FOREBEARANCE

16. In addition to each and every remedy heretofore bereafter described or otherwise existing by law or equity for Mortgagor's breach of any of the terms of this Mortgage or the Mortgage Note it secures, Mortgagor grants Mortgagen, its successors and assigns, the right of set-off against and a upon any deposit, moneys, credits and other property held by such Mortgagee, successor or assignee belonging to the Mortgagor. Each remedy provided in this Mortgage is distinct and cumulative to all other rights or remedies under this Mortgage or afforded by law or equity, and may be exercised concurrently, independently, or successively, in any order whatsoever. Mortgagee's forebearance to exercise any remedy hereunder shall not be deemed and shall not constitute a waiver of any right or remedy hereunder.

APPOINTMENT OF RECEIVER

17. doon, or at any time after the filing of a complaint to foreclose this mortgage, the court in which such complaint is filed may phoint a receiver of said premises. Such appointment may be made of the before or after sale, without notice, without regard to the selvency or insolvency of Mortgagor at the time of application for such receiver and without regard to the then value of the precises or whether the same shall be then occupied as a homestead or not and Mortgagee hereunder or any holder of the note may be appointed as such receiver. Such receiver shall have power to collect the rents, issues and profits of said premises during the prodecty of such foreclosure suit and, in case of a sale and a deficiency, during the full statutory period of redemption, whether there be redemption or not, as well as during any further times when Mortgagor, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the premises during the whole of said period. The court from time to time may authorize the receiver to apply the net income in his hands in payment in whole or in part of; (a) the indebtedness secured hereby, or by any decree foreclosing this mortgage, or any tax, special assessment or other lien which may be or become superior to the lien hereof or of such decree prov del such application is made prior to foreclosure sale; (b) the officiency in case of a sale and deficiency.

ASSIGNMENT OF RENTS AND LEASES

Mortgagor does hereby sell, assign and transfer unto Mortgagee all the rents, issues and profits now due and which may nereafter become due under or by virtue of any lease insofar as it pertains to the premises or any part thereof, whether written or verbal, or any letting of, or of any agreement for the use or occupancy of the premises or any part thereof, which may have been heretofore or may be hereafter made or agreed to or which may be made or agreed to by Mortgagee under the powers herein granted, it being the intention hereby to establish an absolute transfer and assignment of all of such leases and agreements, and all the avails thereunder, unto Mortgagee, and Mortgagor does hereby appoint irrevocably Mortgagee its true and lawful attorney in its name and stead (with or without taking possession of the premises as provided in paragraph 19 hereofl to rent, lease or let all or any portion of said premises to any party or parties at such rental and upon such terms a Mortgagee shall, in its discretion, determine, and to collect all of said avails, rents, issues and

profits arising from or accruing at any time hereafter, and all now due or that may hereafter become due under each and every of the leases and agreements, written or verbal, or other tenancy existing, or which may hereafter exist on said premises, with the same rights and powers and subject to the same immunities, exoneration of liability and rights of recourse and indemnity as Mortgagee would have upon taking possession pursuant to the provisions of paragraph 19 hereof.

Nothing herein contained shall be construed as constituting Mortgagee a mortgagee in possession in the absence of the taking of actual possession of the premises by Mortgagee pursuant to paragraph 19 hereof. In the exercise of the powers herein granted Mortgagee, no liability shall be asserted or enforced against Mortgagee, all such liability being expressly waived and released by Mortgagor.

Mortgagor further agrees to assign and transfer to Mortgagee any loss upon all or any part of the premises hereinbefore describe2 and to execute and deliver, at a request of Mortgagee, all such further assurances and assignments in the premises as Mortgagee shall from time to time require.

Although it is the intention of the parties that the assignment contained in this paragraph 18 shall be a present assignment, it is expressly understood and agreed, anything herein contained to the contrary notwithstanding, that Mortgagee shall not exercise any of the rights or powers conferred upon it by this paragraph until a default shall exist hereunder.

MORTGAGEE'S RIGHT OF POSSESSION IN CASE OF DEFAULT

19. In any case in which under the provisions of this mortgage Mortgage has a right to institute foreclosure proceedings, whether before or after the whole principal sum secured hereby is declared to be immediately due as aforesaid, or whether before or after the institution of legal proceedings to foreclose the lien hereof or before or after sale thereunder, forthwith, upon demand of Mortgages Mortgagor shall surrender to Mortgagee and Mortgagee shall be entitled to take actual possession of the premises or any part hereof personally, or by its agents or attorneys, as for condition broken, and Mortgagee in its discretion may, with or without force and with or without process of law, enter upon and take and maintain possession of all or any part of said premises together with all documents, books, records, papers and accounts of mortgagor or the then owner of the premises relating thereto, and may exclude Mortgagor, its agents or servants, wholly thereform and may as attorney in fact or agent of Mortgagor, or in its own name as Mortgagee and under the powers herein granted, hold operate, manage and control the premises and conduct the busines, if any thereof, either personally or by its agents, and with reli power to use such measures, legal or equitable, as in its discretion or in the discretion of its successors or assigns may be deemed proper or necessary to enforce the payment or security of the avails, rents, issues, and profits of the premises, including actions for the recovery of rent, actions in forcible detainer and actions in distress for rent, hereby granting full power and authority to exercise each and every of the rights, privileges and powers herein granted at any and all times hereafter, without notice to Mortgagor, and with full power to cancel or, terminate any lease or sublease for any cause or on any ground which would entitle Mortgagor to cancel the same, to elect to disaffirm any lease or sublease made subsequent to this mortgage subordinated to the lien hereof, to make all necessary or proper repairs, decorating, renewals, replacements, alterations,

additions, betterments and improvements to the premises as to lit may seem judicious, insure and reinsure the same and all risks incidental to Mortgagee's possession, operation and management thereof and to receive all of such avails, rents, issues and profits.

Mortgagee shall not be obligated to perform or discharge, nor does it hereby undertake to perform or discharge, any obligation, duty or liability under leases, and Mortgager shall and does hereby agree to indemnify and hold Mortgagee harmless of and from any and all liability, loss or damage which it may or might incur under said leases or under or by reason of the assignment thereof and of and from any and all claims and demands whatsoever which may be asserted against it by reason of any alreged obligations or undertakings on its part to perform or discharge and of the terms, covenants or agreements contained in said leases. Should Mortgagee incur any such liability, loss or damage, under said leases or under or by reason of the assignment thereof, or in the defense of any claims or demands, the amount thereof, including costs, expenses and reasonable attorneys' fees, sharl be secured hereby, and Mortgagor shall reimburse Mortgagee therefor immediately upon demand.

APPLICATION OF INCOME RECEIVED BY MORTGAGEE

- 20. Mortgage, in the exercise of the rights and powers hereinabove conferred upon it by paragraph 18 and paragraph 19 hereof shall have 1923 power to use and apply the avails, rents, issues and profits of the premises to the payment of or on account of the following, in such order as Mortgagee may determine:
 - (a) to the paymen, of the operating expenses of said property, including cost of management and leasing thereof (which shall include reasonable compensation to mortgagee and its agent or agents, if management be delegated to an agent or agents, and shall also include lease commissions and other compensation and expenses of seeking and procuring tenants and entering into leases); established claims for damages, if any, and premiums in insurance hereinabove authorized;
 - (b) to the payment of taxes and special assessments now due or which may hereafter become due or said premises;
 - (c) to the payment of all repuirs, decorating, renewals, replacements, alterations, additions, betterments, and improvements of said premises, and of placing said property in such condition as will, in the indement of Mortgagee, make it readily rentable;
 - (d) to the payment of any indebtedness secured hereby or any deficiency which may result from any foreclosure sale.

MORTGAGEF'S RIGHT OF INSPECTION

21. Mortgagee shall have the right to inspect the premises at all reasonable times and access thereto shall be permitted for that purpose.

LATE CHARGE

22. In the event Mortgagee shall, from time to time, accept payment of any installment required on the note and under this mortgage which is more than fifteen (15) days in arrears without exacting payment of interest at the higher rate payable after

maturity, Mortgagee may, at its option, in lieu of such higher rate of interest, collect a "late charge" not to exceed five cents (\$.05) for each one dollar (\$1.00) of each such delinquent installment payment to cover the extra expense involved in handling delinquent payments; provided, however, that nothing in this paragraph contained shall authorize Mortgagee to collect or demand any payment which would result in the imposition of interest in excess of the maximum amount allowed by law.

CONDEMNATION

23. Mortgagor hereby assigns, transfers and sets over unto Mortgagee the entire proceeds of any award or any claim for damages for any of the mortgaged property taken or damaged under the power of eminent domain or by condemnation. Mortgagee elect to apply the proceeds of the award upon or in reduction of' the indebtedness secured hereby, whether due or not, t o require indebtedness secured hereby, whether due or not, or to require Mortgagor to restore or rebuild, in which event the proceeds shall be held by Mortgagee and used to reimburse Mortgagor for the cost of the rebuilding or restoring the buildings or improvements on said premises, in accordance with plans and specifications to be submitted to and approved by Mortgagor is obligated to restore or replace the Mortgagee. damaged or descroyed buildings or improvements under the terms of any lease or leases which are or may be prior to the lien of this mortgage and if such taking does not result in cancellation or termination of such lease, the award shall be used to reimburse Mortgagor for the cost of the rebuilding or restoring of buildings or improvements on said premises, provided Mortgagor is not then in default under this mortgage. In the event Mortgagor is required or authorized, either by Mortgagee's election as aforesaid, or by virtue or any such lease, to rebuild or restore, the proceeds of the award shall be paid out in the same manner as is provided in paragraph 4 hereof for the payment of insurance proceeds toward the cost of rebuilding or restoration. If the amount of such award is insufficient to cover the cost of rebuilding or restoration, Mor(gigor shall pay such cost in excess of the award, before being entitled to reimbursement out of the award. Any surplus which may remain out of said award after payment of such cost of rebuilding or restoration shall, at ist on account of the paid to any other party the option of Mortgagee, be applied indebtedness secured hereby or be paid indebtedness secured hereby entitled thereto.

RELEASE UPON PAYMENT AND DISCHARGE OF MORTGATOR'S OBLIGATIONS

24. Mortgagee shall release this mortgage and the lien thereof by proper instrument upon payment and discharge of all indebtedness secured hereby and payment of a reasonable fee to Mortgagee for the execution of such release.

GIVING OF NOTICE

25. Any notice which either party hereto may desire or be required to give to the other party shall be in writing and the mailing thereof by certified mail addressed to Mortgagor at the mortgaged premises (designated by street address) or to the Mortgagee at its place of business or at such other place as any party hereto may by notice in writing designate as a place for service of notice, shall constitute service of notice hereunder.

WAIVER OF STATUTORY RIGHTS

26. Mortgagor shall not and will not apply for or avail itself of any appraisement, valuation, stay, extension or exemption laws, or any so-called "moratorium laws", now existing

or hereafter enacted, in order to prevent or hinder the enforcement of foreclosure of this mortgage, but hereby waives the benefit of such laws. Mortgagor for itself and all who may claim through or under it waives any and all right to have the property and estates comprising the mortgaged property marshalled upon any foreclosure of the lien hereof and agrees that any court having jurisdiction to foreclose such lien may order the mortgaged property sold as an entirety. Mortgagor hereby waives all rights of homestead exemption in the premises and any and all rights of redemption from sale under any order of decree of foreclosure of this mortgage on its behalf and on behalf of each and every person, except decree or judgment creditors of Mortgagor, acquiring any interest in or title to the premises subsequent to the date of this mortgage.

FURNISHING OF FINANCIAL STATEMENTS TO MORTGAGEE

27. Mortgagor covenants and agrees to furnish to Mortgagee such formicial statements as Mortgagee may reasonably require.

BINDING O' SUCCESSORS AND ASSIGNS

28. This mortgage and all provisions hereof, shall extend to and be binding upon Mortgagor and all persons claiming under or through Mortgagor, and the word "Mortgagor" when used herein shall include all such persons and all persons liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the note or this mortgage. The word "Mortgagee" when used herein shall include the successors and assigns of mortgagee named herein, and the holder or holders, from time to time, of the note secured hereby.

LESSEE ATTORNMENT

29. In the event of the enforcement by Mortgagee of the remedies provided for by the liw or by this Mortgage, the lessee under each lease of all or any part of the Premises made after the date of recording this Mortgage, if any, shall, at the option of the Mortgagee, attorn to any person succeeding to the interest of Mortgagor, as a result of such enforcement and shall recognize such successor in interest as landlord under such lease without change in the terms or other provisions thereof, provided, however, that the said successor in interest shall not be bound by any payment of rent or additional rent for more than one month in advance or any amendment or modification to any lease made without the prior consent of Mortgagee or haid successor in interest, shall execute and deliver an instrument or instruments confirming such attornment, and Mortgagor shall cause each such lease of all or any part of the Premises to contain a covenant on the lessee's part evidencing its agreement to such attornments.

TRANSFER OF PROPERTY OR INTEREST IN MORTGAGOR; ASSUMPTION

30. On sale or transfer of (i) all or any part of the premises, or any interest therein, or (ii) any beredicial interest in any land trust which may hereafter acquire title to the premises, to any person or entity, Mortgagee may, at its option, declare all sums secured by this Mortgage to be immediately due and payable, and Mortgagee may invoke any other remedies provided by this Mortgage, law or equity. This option shall not apply when the Mortgagee prior to the transfer or sale consents in writing to such transfer or sale subject to whatever terms the Mortgagee may require, including, an increase in the rate of interest payable under the note secured hereby.

Notwithistanding anything herein or in the note to the contrary, nothing herein or therein shall be deemed to prohibit transfers of interests in the Premises made in the ordinary course of business, subject to any limitations of the Construction Loan Agreement. Notwithstanding anything herein or in the note or the Construction Loan Agreement to the contrary, Lender shall execute and deliver a Release Deed for each completed residential condominium unit upon the sale and completed residential condominium unit upon the sale conveyance of each said unit and Lender's receipt of 90% of the contract price of the unit.

COLLATERAL AGREEMENT

The note secured by this Mortgage evidences a loan to finance in part certain improvements to the Premises, which loan will be disbursed in the amounts and pursuant to the terms of a Construction Loan Agreement. The Construction Loan Agreement, as the same may from time to time be amended or modified, is hereby incorporated in the Mortgage by reference. If any of the terms and provisions of the Construction Loan Agreement are inconsisters with the terms of this Mortgage, the provisions of the Construction Loan Agreement shall prevail.

The captions and headings of various paragraphs of this mortgage are for convenience only and are not to be construed as defining or limiting, in any way, the scope or intent of the Christopher Walberg provisions hereof.
