Parcel 1: Lot 2 in George A. Seaverns Subdivision of Lots 1 to 44 inclusive and Lots 61 to 62 inclusive and vacated streets and alleys in the Subdivision of Block 6 in the Canal Trustees Subdivision of the East balf of Section 31, Township 39 North, Range 14, East of the Third Principal Meridian, (except that part of said Lot 2 bounded and described as follows: commencing at the North East corner of Lincoln Street and West 33rd Street as shown on the plat of said George A.
