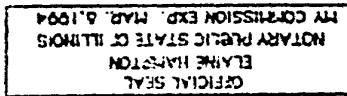

WHEREFORE, the Claimant, City of Chicago, a Municipal Corporation claims a lien against the herein described property in the amount of \$2,334.33, with statutory interest from this date.

9) That as of this date said owner, titleholders or parties are not entitled to any credits on account; leaving due, unpaid, and owing to the Claimant the amount claimed herein.

8) That notice of the filing of this claim for lien was mailed to "owner or owners and party or parties interested in the premises" located at 6800 N. Wayne, Chicago, Illinois 60614 on 6/9/90, and the amount claimed herein represents both the indebtedness due as of the notice date, and any subsequent amounts which may have accrued.

7) That the above amounts became delinquent on 5/16/90.

6) That the total amount due the Claimant therefore is \$2,334.33.

5) That the amount due for sewer service is \$1,022.91.
