and this agreement is hereby made a part of the original Note as completely as if incorporated verbatim therein and said Note is hereby referred to and made a part hereof.

It is agreed that the above stated amount, receipt of which is hereby acknowledged, shall be added to the present unpaid balance of said indebtedness and that the unpaid balance is as of this date, including such advance the sum of Two Hundred Thousand Nine Hundred Ninety One and 99/100 ----- Dollars (\$200,991.99), all of which the undersigned promise to pay with interest at 12% per annum until paid and that the unpaid balance as of this date shall be payable Two Thousand Four Hundred Eighty and 81/100 ----- Dollars (\$2,480.81) per month, the next payment being due on the 1st ----- day of July 1990, and that such payment shall be applied first, to interest and balance to principal until said indebtedness is paid in full. In all other respects, said loan contract shall remain in full force and effect. I certify that I am the owner of said property subject to said indebtedness and that there are no other liens or claims against it. Plus 1/12th of the annual real estate tax bill paid monthly.


