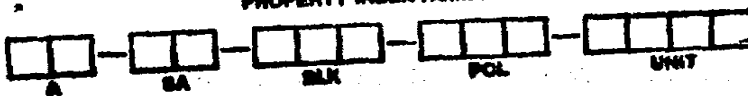

agrees with IFTIKHAR QURESHI, MARRIED TO MARIA QURESHI (Debtor")  
to grant the following extension of payment.

Edgewater agrees to extend the time of payment of the unpaid  
balance presently due and owing in the amount of \$81,089.10 from  
Debtor to Edgewater until the 15th day of June, 1991, being the  
sum secured by a note and mortgage in its original amount of  
\$85,000.00, from IFTIKHAR QURESHI MARRIED TO MARIA QURESHI to  
Community Bank and Trust Company of Edgewater and dated June 15,  
1990, and recorded in the Recorder of Deeds office in and for the

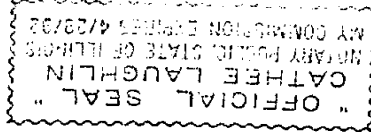
