

The corporation is formed for the following purposes:

To launder, press, renovate, repair, alter, dye, finish and otherwise service fabrics and wearing apparel of all kinds, and in general to engage in the cleaning business in all of its phases, and to manufacture, produce, buy, hold, sell, and deal in all macerials, equipment, and property appurtenant or incident to and useful in the cleaning business.
- 3. To engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
- 4. To acquire, own, use, convey, and otherwise dispose of and deal in real property or any interest therein.
- 5. To enter into any law'ul arrangement for sharing profits and losses in any transaction or transactions, and to promote and organize other corporations.
- 6. To have and to exercise all the power now or hereafter conferred by the laws of the State of Illinois upon corporations organized pursuant to the laws under which the corporation is organized and any all acts amendatory thereof and supplemental thereto.
- 7. To do such other such things as a eincidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
