## MORTGAGE

THIS MORTGAGE & DATED JULY 12, 1990, between James R. Durnbaugh and Cynthia P. Durnbaugh, , his wife, whose address is 1225 W. 165th Street, Tinley Park, IL 60477 (referred to below as "Grantor"); and Heritage Bank Tinley Park, whose address is 17500 Oak Park Avenue, Tinley Park, IL 60477 (referred to below as "Lender").

GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages, warrants, and conveys to Lander all of Grantor's right, tille, and interest in and to the following described real properly, together with all existing or subsequently erected or allized buildings, improvements and fixtures; all essements, rights of way, and appurtenence: A trater, water rights, watercourses and dich rights (including stock in utilities with ditch or impation rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar matters, located in Cook County, State of illinois (the "Real Property"):

The Real Property or its address is commonly known as 7528 W. 165th Street, Tinley Park, II. 60477. The Real Property tax identification number is 27-24-407-016.

Grantor presently assigns to Lender all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property. In addition, Grantor grants to Lender a Uniform Commercial Code security interes. Fig. 9 Personal Property and Rents.

DEFINITIONS. The following words shall have the following meanings when used in this Mortgage. Terms not otherwise defined in this Mortgage shall have the meanings attributed to such terms in the Illinois Uniform Commercial Code.

Credit Agreement. The words "Credit Agreement" mean the revolving line of credit (gree ment dated July 12, 1990, between Lender and Grantor with a credit limit of \$15,000.00, together with all renewals of, extensions of, modifications of, refinancings of, consolidations of, and substitutions for the Credit Agreement. The interest rate to be applied to the cutstanding account balance of the extensions of an extension.

Existing indebtedness. The words "Edsting indebtedness" mean the indebtedness described in our in the Edsting indebtedness section of this Montange.

Grantor. The word "Grantor" means James R. Durnbaugh and Cynthia P. Durnbaugh. The Grantor who mortgagor under this Mortgage.

Guarantor. The word "Guarantor" means and includes without limitation each and all of the guarantors, surer as, and accommodation parkes in connection with the indebtedness.

temprovements. The word "Improvements" means and includes without firmitation all existing and future arrangements, fixtures, buildings, constructions, mobile homes afficed on the Real Property, facilities, additions and other construction on the Real Property.

Indebtedness. The word "Indebtedness" means all principal and interest payable under the Credit Agreement and will amounts expended or the advanced by Lender to discharge obligations of Grantor or expenses incurred by Lender to enforce obligations of Grantor under this Mortgage. Specifically, without limitation, this Mortgage accures a revolving line of credit, which obligates Lender to make advances to Grantor so long as Grantor compiles with all the terms of the Credit Agreement. Such advances may be made, repaid, and remade from time to time, subject to the limitation that the total outstanding balance owing at any one time, not including finance charges on such balance at a fixed or variable rate or sum as provided in the Credit Agreement, any temporary overages, other charges, and any amounts expended or advanced as provided in this paragraph, shall not exceed the Credit Limit as provided in the Credit Agreement. It is the intention of Grantor and Lender that this Mortgage secures the balance outstanding under the Credit Agreement from time to time from zero up to the Credit Limit as provided above and any intermediate balance. The first of this Mortgage shall not exceed at any one time \$15,000.00.

Lander. The word "Lander" means Heritage Bank Tinley Park, its successors and assigns. The Lander is the mortgages under this Mortgage

Mortgage. The word "Mortgage" means this Mongage between Grantor and Lender, and includes without limitation all assignments and security interest provisions relating to the Personal Property and Rents.

Personal Property. The words "Personal Property" meen all equipment, fidures, and other articles of personal property now or hereafter owned by Grantor, and now or hereafter attached or affixed to the Real Property; together with all accessions, parts, and additions to, all replacements of, and all substitutions for, any of such property; and together with all proceeds (including without limitation all insurance proceeds and refunds of premiums) from any sale or other disposition of the Property.

Presently. The word "Property" means collectively the Real Property and the Personal Property.

Real Property. The words "Real Property" mean the property, interests and rights described above in the "Grant of Mortgage" section.

Related Documents. The words "Related Documents" mean and include without limitation all promissory notes, credit agreements, loan agreements, guaranties, security agreements, mortgages, deeds of trust, and all other instruments and documents, whether now or hereafter

existing, executed in connection with Granton's Indebtedness to Lender.

Rests. The word "Rents" means all present and future rents, revenues, income, issues, royalties, profits, and other benefits derived from the Property.

THIS MORTGAGE, INCLUDING THE ASSIGNMENT OF RENTS AND THE SECURITY INTEREST IN THE RENTS AND PERSONAL PROPERTY, IS GIVEN TO SECURE (1) PAYMENT OF THE INDEBTEDNESS AND (2) PERFORMANCE OF ALL OBLIGATIONS OF GRANTOR UNDER THIS MORTGAGE AND THE RELATED DOCUMENTS. THIS MORTGAGE IS GIVEN AND ACCEPTED ON THE FOLLOWING TERMS:

PAYMENT AND PERFORMANCE. Except as otherwise provided in this Mortgage, Grantor shall pay to Lender all amounts secured by this Mortgage as they become due, and shall strictly perform all of Grantor's obligations under this Mortgage.

POSSESSION AND MAINTENANCE OF THE PROPERTY. Grantor agrees that Grantor's possession and use of the Property shall be governed by the following provisions:

Possession and Use. Until in detault, Grantor may remain in possession and control of and operate and manage the Property and collect the Rante from the Property.

Duty to Maintain. Grantor shall maintain the Property in tenentable condition and promptly perform all repairs, replacements, and maintenance necessary to pressive its value.

Hazardous Substancia. The terms "hazardous wasts," "hazardous substance," "disposal," "release," and "threatened release," as used in this Mortgage, shall have the same meanings as set forth in the Comprehensive Environmental Response, Compensation, and Liability Act of 1980, as arrended, 42 U.S.C. Salain 9601, of seq. ("CERCLA"), the Superland Amendments and Resultionization Act of 1986, Pub. L. No. 99-498 ("SARA"), the Hezerdouc Allight Transportation Act, 48 U.S.C. Section 1801, et seq., the Resource Conservation and Recovery Act, 49 U.S.C. Section 6901, et seq., or other procedures et ale or Federal laws, rules, or regulations adopted pursuant to any of the foregoing. Grantor represents and warrants to Lander that: (c) During the period of Granton's ownership of the Property, there has been no use, generation, manufacture, storage, treatment, disposal, release of threatened release of any hazardous waste or substance by any person on, under, or about the Property. (b) Grantor has no knowledge of, or reason to believe that there has been, except as previously disclosed to and acknowledged by Lender in writing. (f) any use, generation, manufactive, strage, treatment, disposal, release, or threatened release of any hazardous waste or substance by any prior owners or occupants of the Property or (8) any actual or threatened litigation or claims of any kind by any person relating to such tiers. (c) Except as previously disclosed to an a knowledged by Lender in writing, (f) neither Grantor nor any tenant, contractor, agent or other authorized user of the Property shall use, generate, manufacture, store, treat, dispose of, or release any hazardous waste or substance on, under, or about the Property and (ii) any such acryst shall be conducted in compliance with all applicable tederal, state, and local laws, regulations and ordinances, including without limitation of laws, regulations, and ordinances described above. Grantor authorizes Lander and its approis to enter upon the Property to make such in committees and tests as Lender may deem appropriate to determine compliance of the Property with this section of the Morigage. Any inspections or tests made by Lender shall be for Lender's purposes only and shall not be construed to create any responsibility or Eability on the part of Lands to Grantor or to any other person. The representations and warrantees contained herein are based on Granton's due diligence in investigating the Property for hezardous waste. Granton hereby (a) releases and waives any future claims against Lender for indemnity or contribution in the event Grantor becomes liable for cleanup or other costs under any such laws. and (b) agrees to indemnity and hold harmless Lander against any well all claims, losses, liabilities, damages, penalties, and expenses which Lander may directly or indirectly sustain or suffer resulting from a breast of this section of the Mongage or as a consequence of any use, generation, manufacture, storage, disposal, release or threatened release occurring prior to Grantor's ownership or interest in the Property. mether or not the same was or should have been known to Grantor. The provisions of this section of the Mortgage, including the obligation to indemnily, shall survive the payment of the Indebtedness and the satisfaction and recommended in the field of this Mortgage and shall not be affected by Lender's acquisition of any interest in the Property, whether by foreclosure or othe wise.

Mulsance, Waste. Grantor shall not cause, conduct or permit any nuisance nor comme, primit, or suffer any stripping of or waste on or to the Property or any portion of the Property. Specifically without limitation, Grantor will not remove, or grant to any other party the right to remove, any timber, minerale (including oil and gas), soil, gravel or rock products without the prior written constant. Lender.

Removal of Improvements. Grantor shall not demolish or remove any improvements from the Ref. Property without the prior written consent of Lander. As a condition to the removal of any improvements, Lender may require Grantor to make arm a small stactory to Lender to replace such improvements with improvements of at least equal value.

Lender's Right to Enter. Lender and its agents and representatives may enter upon the Real Property of the Casonable times to attend to Lender's interests and to inspect the Property for purposes of Grantor's compliance with the terms and conditions of this Mongage.

Compliance with Governmental Requirements. Grantor shall promptly comply with all laws, ordinances, and regressions, now or hereafter in effect, of all governmental authorities applicable to the use or occupancy of the Property. Grantor may contest in good faith any such law, ordinance, or regulation and withhold compliance during any proceeding, including appropriate appeals, so long as Grantor has notified Lender in writing prior to doing so and so long as Lender's interests in the Property are not jeopardized. Lender may require Grantor to post adequate security or a surety bond, reasonably satisfactory to Lender, to protect Lender's interest.

Duty to Protect. Grantor agrees neither to abandon not leave unattended the Property. Grantor shall do all other acts, in addition to those acts set forth above in this section, which from the character and use of the Property are reasonably necessary to protect and preserve the Property.

DUE ON SALE - CONSENT BY LENDER. Lender may, at its option, declare immediately due and psyable all sums secured by this Mortgage upon the sale or transfer, without the Lender's prior written consent, of all or any part of the Real Property, or any interest in the Real Property. A "sale or transfer" means the conveyance of real property or any right, title or interest therein; whether legal or equitable; whether voluntary or involuntary; whether by outsight sale, deed, installment sale contract, land contract for deed, leasehold interest with a term greater than three (3) years, lease-option contract, or by sale, assignment, or transfer of any beneficial interest in or to any land trust holding title to the Real Property, or by any other method of conveyance of real property interest. If any Grantor is a corporation or partnership, transfer also includes any change in ownership of more than twenty-live percent (25%) of the voting stock or partnership interests, as the case may be of Grantor. However, this option shall not be exercised by Lender II such exercise is prohibited by federal law or by illinois law.

TAXES AND LIENS. The following provisions relating to the taxes and liens on the Property are a part of this Mortgage.

Payment. Grantor shall pay when due (and in all events prior to delinquency) all taxes, payroil taxes, special taxes, essessments, water charges and sever service charges levied against or on account of the Property, and shall pay when due all claims for work done on or for services rendered or material turnished to the Property. Grantor shall maintain the Property tree of all liens having priority over or equal to the interest of Lender under this Mortgage, except for the lien of taxes and assessments not due, except for the Existing Indebtedness related to below, and except as otherwise provided in the following paragraph.

Right To Contest. Grantor may withhold payment of any tax, assessment, or claim in connection with a good faith citapute over the obligation to pay, so long as Lander's interest in the Property is not jeopardized. If a fien arises or is filed as a result of nonpayment, Grantor shall within these

(15) days after the tien arises or, it a tien is filled, within litteen (15) days after Grantor has notice of the filling, secure the discharge of the fien, or if requested by Lender, deposit with Lender cash or a sufficient corporate surety bond or other security satisfactory to Lender in an amount sufficient to discharge the fien plus any costs and attempted fees or other charges that could accrue as a result of a foreclosure or sale under the Sen. In any contest, Grantor shall defend itself and Lender and shall satisfy any adverse judgment before enforcement against the Property. Grantor shall name Lander as an additional obliges under any surety bond furnished in the contest proceedings.

Evidence of Payment. Grantor shall upon demand furnish to Lander satisfactory evidence of payment of the taxes or assessments and shall authorize the appropriate governmental official to deliver to Lender at any time a written statement of the taxes and assessments against the Property.

Notice of Construction. Grantor shall notify Lander at least litteen (15) days before any work is commenced, any services are furnished, or any materials are supplied to the Property, if any mechanic's lien, materialmen's lien, or other Sen could be asserted on account of the work, services, or materials and the cost exceeds \$2,500.00. Grantor will upon request of Lender furnish to Lender advance assurances satisfactory to Lender that Grantor can and will pay the cost of such improvements.

PROPERTY CAMAGE INSURANCE. The following provisions relating to insuring the Property are a part of this Mortgage.

Maintenance of Insurance. Grantor shall procure and maintain policies of fire insurance with standard extended coverage endorsaments on a replacement ber's for the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of any colineurance classes, and with a standard mortgages clause in tevor of Lender. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender. Grantor shall deliver to Lander certificates of coverage from each insurar containing a stipulation that coverage will not be cancelled or diminished without a minimum of ten (10) days' prior written notice to Lender.

Application of Proce/As. Grantor shall promptly notify Lander of any loss or damage to the Property if the estimated cost of repair or replacement exceeds \$1,000,000. Lender may make proof of loss if Grantor fails to do so within fifteen (15) days of the casually. Whether or not Lander's security is impaired, Union may, at its election, apply the proceeds to the reduction of the Indebtedness, payment of any lien affecting the Property, or the restoration and repair of the Property. If Lender elects to apply the proceeds to restoration and repair, Grantor shall repair or replace the damaged or destroyed improvements in a manner satisfactory to Lander. Lander shall, upon satisfactory proof of such expenditure, pay or reimburse Grantor from the proceeds for the reasonable cost of repair or restoration if Grantor is not in default hereunder. Any proceeds which have not been disbursed within 100 days after their receipt and which Lender has not committed to the repair or restoration of the Property shall be used that to pay any amount owing to having the lander holds any proceeds after payment in full of the Indebtedness, such proceeds shall be paid to Grantor.

Unexpired insurance at Sale. Any unexpired insurance shell insure to the benefit of, and pass to, the purchaser of the Property covered by this Mortgage at any trustee's sale or other sale held under but melsions of the Mortgage, or at any foreclosure sale of such Property.

Compliance with Existing Indebtedness. During the period in which any Existing Indebtedness described below is in effect, compliance with the insurance provisions contained in the instrument evidencing such Existing Indebtedness shall constitute compliance with the insurance provisions under this Mortgage, to the extent compliance with the terms of unit infortgage would constitute a duplication of insurance requirement. If any proceeds from the insurance become payable on loss, the provision in this Mortgage for division of proceeds shall apply only to that portion of the proceeds not payable to the holder of the Existing Indebtedness.

EXPENDITURES BY LENDER. If Grantor falls to comply with any provision of this Magage, including any obligation to maintain Existing Indebtedness in good standing as required below, or it any action or proceeding is commenced that would materially affect Lender's interests in the Property, Lender on Grantor's behalf may, but shall not be required to, take any action that Lender deams appropriate. Any amount that Lender expends in so doing will bear interest at the rate charged under the Credit Agreement from the date incurred or prior by Lender to the date of repayment by Grantor. All such expenses, at Lender's option, will (a) be payable on demand, (b) be added to the bactors of the credit line and be apportioned among and be payable with any installment payments to become due during either (i) the term of any appropriate insurance policy or (ii) the remaining term of the Credit Agreement, or (c) be treated as a balloon payment which will be due and payable at the Credit Agreement's maturity. This Mortgage also will secure payment of these amounts. The rights provided for in this paragraph shall be in addition to pay other rights or any remedies to which Lender may be entitled on account of the default. Any such action by Lender shall not be construed as curing the Catalit so as to ber Lender from any remedy that it otherwise would have had.

WARRANTY: DEFENSE OF TITLE. The following provisions relating to ownership of the Property are a part of this I longage.

Title. Grantor warrants that: (a) Grantor holds good and marketable title of record to the Property in fee stripe are and clear of all tiens and encumbrances other than those set forth in the Real Property description or in the Existing Indebtedness section below or in any title insurance policy, title report, or final title opinion issued in favor of, and accepted by, Lender in connection with this Mortgagy, and (b) Grantor has the foll right, power, and authority to execute and deliver this Mortgage to Lender.

Defense of Title. Subject to the exception in the paragraph above, Grantor warrants and will forever defend the title to the Property against title tentul claims of all persons. In the event any action or proceeding is commenced that questions Grantor's title or the interest of Lander under this Mortgage, Grantor shall defend the action at Grantor's expense. Grantor may be the nominal party in such proceeding, but Lander shall be entitled to participate in the proceeding and to be represented in the proceeding by counsel of its own choice, and Grantor will deliver, or cause to be delivered, to Lander such instruments as Lander may request from time to time to permit such participation.

Compliance With Laws. Grantor warrants that the Property and Grantor's use of the Property complies with all existing applicable laws, ordinances, and regulations of governmental authorities.

EXISTING INDESTEDNESS. The following provisions concerning existing indebtedness (the "Existing Indebtedness") are a part of this Mortgage.

Existing Lies. The lien of this Mortgage securing the indebtedness may be secondary and inferior to an existing lien. Grantor expressly covenants and agrees to pay, or see to the payment of, the Existing Indebtedness and to prevent any default on such indebtedness, any default under the instruments evidencing such indebtedness, or any default under any security documents for such indebtedness.

No Modification. Grantor shall not enter into any agreement with the holder of any mortgage, deed of trust, or other security agreement which has priority over this Mortgage by which that agreement is modified, amended, extended, or renewed without the prior written consent of Lender. Grantor shall neither request nor accept any future advances under any such security agreement without the prior written consent of Lender.

CONDEMNATION. The following provisions relating to condemnation of the Property are a pert of this Mortgage.

Application of Net Proceeds. If all or any part of the Property is condemned by errinent domain proceedings or by any proceeding or purchase in fieu of condemnation, Lender may at its election require that all or any portion of the net proceeds of the award be applied to the indebtedness or the repair or restoration of the Property. The net proceeds of the award shall mean the award after payment of all reasonable costs, expenses, and attorneys' tees necessarily paid or incurred by Grantor or Lender in connection with the condemnation.

Proceedings. If any proceeding in condemnation is filed, Grantor shall promptly notify Lender in writing, and Grantor shall promptly take such

steps as may be necessary to defend the action and obtain the award. Grantor may be the nominal party in such proceeding, but Lender shall be entitled to participate in the proceeding and to be represented in the proceeding by counsel of its own choice, and Grantor will deliver or cause to be delivered to Lender such instruments as may be requested by it from time to time to permit such participation.

IMPOSITION OF TAXES, FEES AND CHARGES BY GOVERNMENTAL AUTHORITIES. The following provisions relating to governmental laxes, fees and charges are a part of this Mortgage:

Current Taxes, Fees and Charges. Upon request by Lender, Grantor shall execute such documents in addition to this Mortgage and take whatever other action is requested by Lender to perfect and continue Lender's lien on the Real Property. Grantor shall reimburse Lender for all taxes, as described below, together with all expenses incurred in recording, perfecting or continuing this Mortgage, including #thout limitation all taxes, decumentary stamps, and other charges for recording or registering this Mortgage.

Taxes. The following shall constitute taxes to which this section applies: (a) a specific tax upon this type of Morigage or upon all or any part of the indebtedness secured by this Morigage; (b) a specific tax on Grantor which Grantor is authorized or required to deduct from payments on the indebtedness secured by this type of Morigage; (c) a tax on this type of Morigage chargeable against the Lencer or the holder of the Credit Agreement; and (d) a specific tax on all or any portion of the indebtedness or on payments of principal and interest made by Grantor.

Subsequent Taxes. If any tex to which this section applies is enacted subsequent to the date of this Mortgage, this event shall have the same effect as an Event of Default (as defined below), and Lender may exercise any or all of its available remedies for an Event of Default as provided below unsess @arm either (a) pays the tax before it becomes definquent, or (b) contests the tax as provided above in the Taxes and Liens section and deposits with Lender cash or a sufficient corporate surety bond or other security satisfactory to Lender.

SECURITY AGREEMENT; FIP MCING STATEMENTS. The following provisions relating to this Mortgage as a security agreement are a part of this Mortgage.

Security Agreement. This is summert shall constitute a security agreement to the extent any of the Property constitutes fixtures or other personal property, and Lander shall have all of the rights of a secured party under the Illinois Uniform Commercial Code as amended from time to time.

Security interest. Upon request by ander, Granior shall execute financing statements and take whatever other action is requested by Lender to perfect and continue Lender's security immed in the Bents and Personal Property. In addition to recording this Mortgage in the real property records, Lender may, at any time and with a further authorization from Grantor, file executed counterparts, copies or reproductions of this Mortgage as a financing statement. Grantor shall executly interest. Upon default, Grantor shall assemble the Person at Property in a manner and at a place reasonably convenient to Grantor and Lender and make it available to Lender within three (3) days after recipit of written demand from Lender.

Addresses. The mailing addresses of Grantor (decay) and Lender (secured party), from which information concerning the security interest granted by this Mortgage may be obtained (each as regions by the Illinois Uniform Commercial Code), are as stated on the first page of this Mortgage.

FURTHER ASSURANCES; ATTORNEY-IN-FACT. The following (rovizions relating to further assurances and attorney-in-fact are a part of this Mortgage.

Further Assurances. At any time, and from time to time, upon requer, of Lender, Grantor will make, execute and deliver, or will cause to be made, executed or delivered, to Lender or to Lender's designee, and with requested by Lender, cause to be filed, recorded, refiled, or rerecorded, as the case may be, at such times and in such offices and packer's Lender may deem appropriate, any and all such mortgages, deede of trust, security deeds, security agreements, financing statements, conviction statements, instruments of further assurance, certificates, and other documents as may, in the sole opinion of Lender, be necessary or desirable in order to effectuate, complete, perfect, continue, or preserve (a) the obligations of Grantor under the Credit Agreement, this Mortgage, and are Related Documents, and (b) the liens and security interests created by this Mortgage on the Property, whether now owned or hereafter undured by Grantor. Unless prohibited by law or agreed to the contrary by Lender in writing, Grantor shall reimburse Lender for all costs and expender in connection with the matters referred to in this paragraph.

Attorney-in-Fact. If Grantor falls to do any of the things referred to in the preceding paragraph. Lender may do so for and in the name of Grantor and at Grantor's expense. For such purposes, Grantor hereby irrevocably appoints Lender at Grantor's attorney-in-fact for the purpose of making, executing, delivering, filing, recording, and doing all other things as may be necessary or destrable, in Lender's sole opinion, to accomplish the matters referred to in the preceding paragraph.

FULL PERFORMANCE. It Grantor pays all the Indebtedness when due, terminates the credit line account, and Continues performs all the obligations imposed upon Grantor under this Mortgage, Lander shall execute and deliver to Grantor a suitable satisfaction of this Mortgage and suitable statements of termination of any financing statement on file evidencing Lander's security interest in the Rents and the Persons Property. Grantor will pay, if permitted by applicable law, any reasonable termination fee as determined by Lander from time to time.

DEFAULT. Each of the following, at the option of Lender, shall constitute an event of default ("Event of Default") under this Mortgage: (a) Grantor commits fraud or makes a material misrepresentation at any time in connection with the credit line account. This can include, for example, a fake statement about Grantor's income, assets, liabilities, or any other aspects of Grantor's financial condition. (b) Grantor does not meet the repayment terms of the credit line account. (c) Grantor's action or inaction adversely affects the collateral for the credit line account or Lender's rights in the collateral. This can include, for example, failure to maintain required insurance, waste or destructive use of the dwelling, failure to pay taxes, death of all persons liable on the account, transfer of title or sale of the dwelling, creation of a lien on the dwelling without Lender's permission, foreclosure by the holder of another lien, or the use of funds or the dwelling for prohibited purposes.

RIGHTS AND REMEDIES ON DEFAULT. Upon the occurrence of any Event of Default and at any time thereafter, Lender, at its option, may exercise any one or more of the following rights and remedies, in addition to any other rights or remedies provided by lew:

Mortgages in Possession. Lender shall have the right to be placed as mortgages in possession or to have a receiver appointed to take

possession of all or any part of the Property, with the power to protect and preserve the Property, to operate the Property preceding foreclosure or sale, and to collect the Rentz from the Property and apply the proceeds, over und above the cost of the receivership, against the indebtedness. The mortgages in possession or receiver may serve without bond if permitted by law. Lender's right to the appointment of a receiver shall exist whether or not the apparent value of the Property exceeds the Indebtedness by a substantial amount. Employment by Lender shall not disquality a person from serving as a receiver.

Judicial Foreclosure. Lander may obtain a judicial decree foreclosing Grantor's interest in all or any part of the Property.

Delicioncy Judgment. If permitted by applicable law, Lander may obtain a judgment for any delicioncy remaining in the Indebtedness due to Lander agenciation of all amounts received from the exercise of the rights provided in this section.

Other Remedies. Lander shall have all other rights and remedies provided in this Mortgage or the Credit Agreement or available at lew or in equity.

Sale of the Property. To the extent permitted by applicable law, Grantor hereby waives any and all right to have the property marshalled. In exercising its rights and remedies, Lender shall be tree to sell all or any part of the Property together or separately, in one sele or by separate sales. Lender shall be entitled to bid at any public sale on all or any portion of the Property.

Notice of Sale. Londer shall give Grantor reasonable notice of the time and place of any public sale of the Personal Property or of the time after which any prives sale or other intended disposition of the Personal Property is to be made. Reasonable notice shall mean notice given at least tan (10) days before the time of the sale or disposition.

Watver; Election of (see edies. A waiver by any party of a breach of a provision of this Mortgage shall not constitute a waiver of or prejudice the party's rights otherwise or demand strict compliance with that provision or any other provision. Election by Lender to pursue any remedy shall not exclude pursuit of any other foredy, and an election to make expenditures or take action to perform an obligation of Grantor under this Mortgage after failure of Grantor to pending all not affect Lender's right to declare a default and exercise its remedies under this Mortgage.

Attorneys' Fees; Expenses. It Line's institutes any spit or action to enforce any of the terms of this Mortgage, Lender shall be entitled to recover such sum as the court array adjusting reasonable as allorneys' fees at trial and on any appeal. Any party may change its address for notices under this Mortgage by giving formal written notice to the other parties, specifying that the purpose of the notice is to change the party's address. All copies of notices of foreclosure from the holder of any link which has priority over this Mortgage shall be sent to Lender's address, as shown near the beginning of this Mortgage. No prior waiver by Lender, nor any course of dealing between Lender and Grantor, shall constitute a waiver of any of Lender's rights or any of Grantor's obligations as to any luture transactions. Whenever consent by Lender is required in this Mortgage, the granting of such consent by Lender in any instance shall not constitute continuing consent to subsequent instances where such consent is required.
