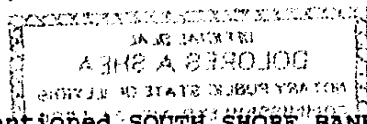
Know all men by these presents, that Suburban Trust and Savings Bank under

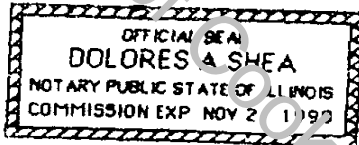
