(2) A tract of land of varying widths, being a part of Parcels "A" and "E" as shown on and described in plat of "Lake Front Plaza", aforesaid.

(1) A tract of Land, being a part of Parcels "C" and "D" as shown on and described in Plan of "Lake Front Plaza", aforesaid.

A. A perpetuital easement for access roadway on and across a strip of land, being a part of tracts "C" and "C-1" as shown on and described in plat of "Lake Front Plaza", aforesaid.

B. A perpetuital easement for sanitary and storm sewers, water mains, electric power lines and telephone lines on and across the premises described as follows:

Examiners took the benefit of Exhibit I, a forecast, as created by grant from Illinois Central Railroad Company to American National Bank and Trust Company of Chicago, as trustee under Trust No. 17400, dated May 1, 1962 and recorded May 7, 1962 as Document 18,467,559 and by grant recarded December 23, 1964 as Document 19,341,547 more perfectly described as follows:

PARCEL I: Unit No. 1411 as delineated on Survey of certain Lots in the Plat of Lake Front Plaza, a subdivision of a parcel of land lying in acreations to Fractional Section 10, Township 39 North, Range 14, East of the Third Principal Meridian, according to the plat thereof, recorded April 30, 1962, as Document No. 18,461, conveyed by deed from Illinois Central Railroad Company to American National Bank and Trust Company of Chicago, as trustee under Trust No. 17460, recorded May 7, 1962, as Document No. 18,467,558, and also supplemental deed thereto recorded December 23, 1964, as Document No. 19,341,545, which survey is attached as Exhibit "A" to Declaration of condominium made by American National Bank and Trust Company of Chicago, as trustee under Trust No. 17460, recorded as Document No. 22,453,315 together with the undivided percentage interest appurtenant to said unit in the property described in said Declaration of condominium (excluding the units as defined and set forth in the Declaration of condominium and survey).
