THIS INDENTURE, made July 27,

1990, between

ANN M. WALSH, a spinster

herein referred to as "Mortgagors," and CHICAGO TITLE AND TRUST COMPANY, an Illinois corporation doing business in Chicago, Illinois, herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS the Mortgagors are justly indebted to the legal holders of the Instalment Note hereinafter described, said legal holder or holders being herein referred to as Holders of the Note, in the principal sum of

ONE HUNDRED FIVE THOUSAND & NO/100 (\$105,000.00)

Dollars,

evidenced by one certain Instalment Note of the Mortgagors of even date herewith, made payable to THE ORDER OF ~~COLEMAN~~ COLEMAN WALSH & BARBARA WALSH, his wife, 4216 N. Mason, Chicago, Ill. 60634

and delivered, in and by which said Note the Mortgagors promise to pay the said principal sum and interest from August 1, 1990 on the balance of principal remaining from time to time unpaid at the rate of 9.0 per cent per annum in instalments (including principal and interest) as follows:

All of the foregoing are declared to be a part of said real estate whether physically attached thereto or not, and it is agreed that all similar apparatus, equipment or articles hereinafter placed in the premises by the mortgagors or their successors or assigns shall be considered constituting part of the real estate.

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever, for the purposes, and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the Mortgagors do hereby expressly release and waive.
