ADDITIONAL CONVENANTS CONDITIONS AND PROVISIONS REFERRED TO ON THE REVERSE SIDE OF THIS MORTGAGE AND INCORPORATED THEREIN BY REFERENCE

- 1. Mortgagors shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed. (2) keep said premises in good condition and repair, without waste and free from more hants so other liens or claims to then not expressly subordinated to the lien hereof. (3) pay when due any Indebtedness which may be secured by a tien or charge on the premises superior to the lien hereof and upon request exhibit satisfactory evidence of the discharge of such prior lien to Mortgager or to build or of the contract of complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises. (3) couply with all requirements of law or municipal ordinances with respect to the premises and the use thereof: (6) make no material alterations or said premises except as required by law or municipal ordinance.
- 2. Mortgagors shall pay before any penalty attaches all general taxes and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall upon written request. Furnish to Mortgagee or to holders of the contract duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest. - 3. - 4. In case of default therein, Mortgagee or the holder of the contract may but need not make any parment of performany act hereinhelore required of Mortgagors in any form and manner deemed expedient, and may but need not make full or partial payments of principal or interest on prior encumbrations if any end purchase, discharge, compromise or settle any tax lies or other prior lies or title or claim thereof or redeem from any tax sale or forfeiture, affecting, said premises or contest any tax or assessment.
