
SHORT FORM LEASE AND OPTION TO PURCHASE

This Short Form Lease and Option to Purchase is made as of April 1, 1991, by and between Inhalation Plastics, Inc., as Lessor, and The NutraSweet Company, as Lessee,

WITNESSETH:

- Lessor and Lessee have entered into that certain Industrial Building Lease (the "Lease") dated April 1, 1991 by which Lessor has leased the premises (the "Premises") described on Exhibit A attached hereto and made a part hereof. Lessor and Lessee are entering into this agreement to give third parties notice of certain of the terms of the Lease. Lessor, for and in consideration of the rents and covenants contained in the Lease, hereby leases the Premises to Lessee for a one-year period beginning on May 25, 1991 and ending on May 24, 1992
- 2. Lessee shall have an option to renew the lease for an additional 4-year period beginning on May 25, 1992 and ending on May 24, 1996. If such option is not exercised by Lessee on or before January 2, 1992, it shall be null and void and of no further force or effect.
- 3. Lessee shall have the option to purchase the Premises at the price specified in the Lease. If such option is not exercised by Lessee on or before January 2, 1992, it shall be null and void and of no further force or effect. Lessee will execute and deliver a termination document in form and substance satisfactory to Lessor, if such option is not exercised.
- 4. In the event Lessee does not exercise its option to purchase, but exercises its option to renew the Lease, Lessee shall have a right of first refusal with respect to the Premises. Lessee shall not have the right to sell the Premises except in accordance with the terms hereof and of the Lease. Lessor shall notify Lessee of any offer it receives for the Premises that it desires to accept, and Lessee shall have the first right and option to purchase the Premises upon the same terms and conditions as those specified in the notice it receives from Lessor. If such right of first refusal is not exercised within 15 days after the date Lessee receives notice of such offer from Lessor, such right shall be null and void and of no further force or effect.
- 5. All terms and conditions of the Lease are hereby incorporated herein by reference. In the event of any conflict between the terms hereof and the terms of the Lease, the terms of the Lease shall control, provided, however, the dates set forth in No. 1 and 2 above shall control.
