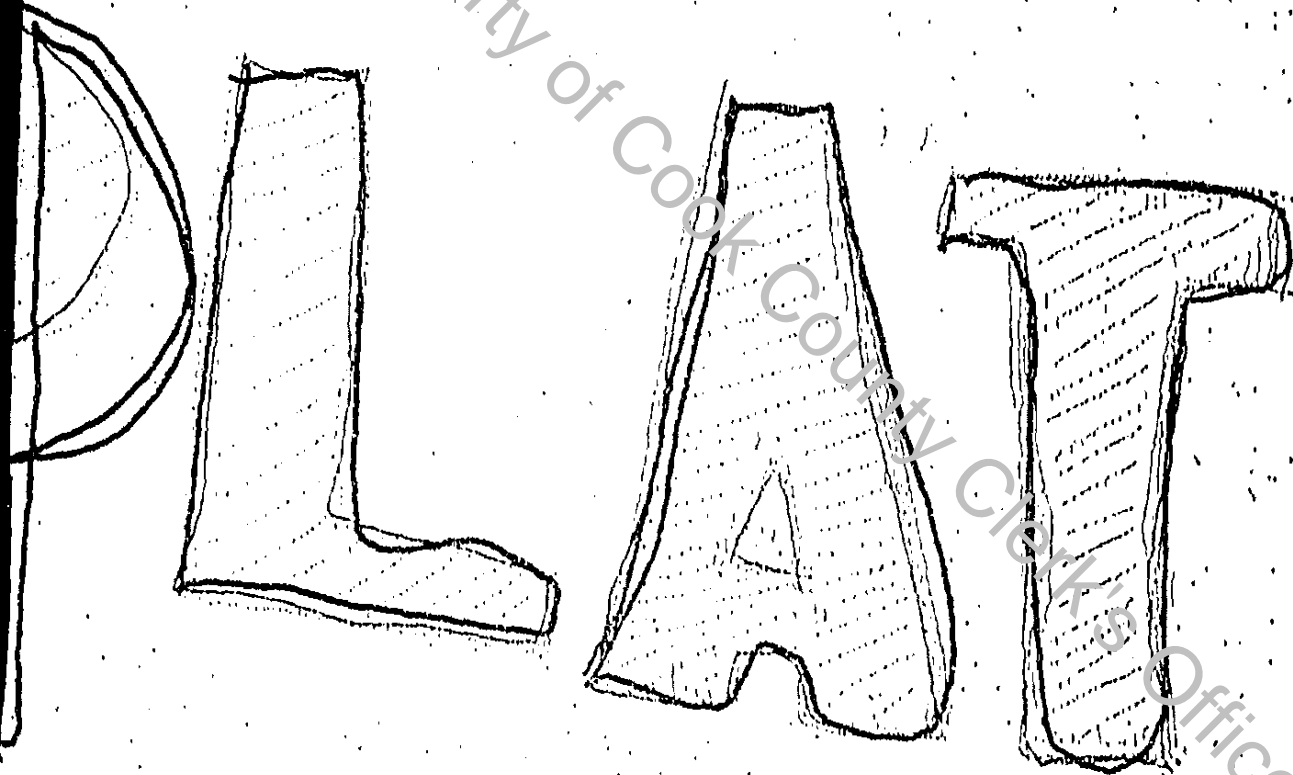

ORDINANCE NO. 1991-16

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF RIVER GROVE, COOK COUNTY, ILLINOIS

WHEREAS, a Quo Warranto action has heretofore been filed challenging the validity of annexations of certain properties to the Village of River Grove by the Village of Melrose Park, said cause being numbered 87 CH 12375 in the Circuit Court of Cook County, Illinois; and

WHEREAS, the Summary Judgment order entered in said cause is presently on appeal to the Appellate Court of Illinois, First Judicial District said appeal now pending; and

WHEREAS, no order has been entered staying the effect of said Summary Judgment order; and

WHEREAS, the Community College District 504, Triton College has filed a petition in writing signed by the Chairman and attested to by the Secretary and approved by the other members of the Board of Trustees, to annex to the Village of River Grove; and

WHEREAS, the Secretary of the Board of Trustees of Triton College has transmitted a copy of aforesaid petition to the corporate authorities of the Village of River Grove; and

WHEREAS, a Petition in writing signed by all the owners of record of the unincorporated territory hereinafter described has been filed with the Village Clerk in accordance with Section 7-1-8, Article 24, Illinois Revised Statutes, ~~1971~~, as amended; and

WHEREAS, said petition has been presented to the Board of Trustees of the Village of River Grove requesting that such territory be annexed to the Village of River Grove; and

WHEREAS, there are no electors residing on said territory; and

WHEREAS, the territory hereinafter described is contiguous to the Village of River Grove; and

WHEREAS, the Village of River Grove desires to annex said territory; and

WHEREAS, all petitions and other necessary legal requirements are in full compliance with the requirements of the state of Illinois, specifically Section 7-1-8 and Section 7-1-14 of Chapter 24, Illinois Revised Statutes, 1989;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of River Grove, Cook County, Illinois as follows:

Section 1. That the legal description of the property to be annexed is as follows:

PARCEL NUMBER ONE

The North 20.45 acres of that part of the Northeast Quarter of the Southwest Quarter lying West of the East 10 acres of said Northeast Quarter of the Southwest Quarter of Section 35, Township 40 North, Range 12, East of the Third Principal Meridian (except from said premises the West 33 feet thereof).

PARCEL NUMBER TWO

That part of the Southwest Quarter of the Northwest Quarter and the Northwest Quarter of the Southwest Quarter of Section 35, Township 40 North, Range 12, East of the Third Principal Meridian and the Southeast Quarter of the Northeast Quarter and the Northeast Quarter of the Southeast Quarter of Section 34, Township 40 North, Range 12 East of the Third Principal Meridian described as follows: Beginning at a point on the

West line of said Southwest quarter of the Northwest Quarter of Section 35 which is 366 feet South of the Northwest corner of said Southwest Quarter of the Northwest Quarter; thence East parallel with the North line of said Southwest Quarter of the Northwest Quarter, a distance of 300 feet; thence North parallel with the West line of said Southwest Quarter of the Northwest Quarter, a distance of 333 feet to a point in a line 33 feet South of and parallel with the North line of said Southwest Quarter of the Northwest Quarter; thence East on said parallel line a distance of 997.95 feet, more or less to a line 33 feet West of and parallel with the East line of said Southwest Quarter of the Northwest Quarter; thence South on last said parallel line a distance of 1808.25 feet, more or less, to a point 509.14 feet south of the North line of the said Northwest Quarter of the Southwest Quarter of Section 35; thence West at right angles to the East line of said Northwest Quarter of the Southwest Quarter, a distance of 317 feet; thence South at right angles to the last described course, a distance of 150 feet; thence West at right angles to the last described course, a distance of 924.62 feet, more or less, to the Northeastery right-of-way line of the Minneapolis, St. Paul and Saulte Ste. Marie Railroad; thence Northwesterly along the Northeastery right-of-way line of said railroad, a distance of 914.61 feet, more or less, to the North line of said Northeast Quarter of the Southeast Quarter of Section 34; thence East along the North line of said Northeast Quarter of Southeast Quarter, a distance of 81.77 feet; thence North parallel with the East line of the Southeast Quarter of the Northeast Quarter of said Section 34, a distance of 618.7 feet; thence East parallel with the North line of said Southeast Quarter of the Northeast Quarter, a distance of 495.41 feet to the East line of said Southeast Quarter of the Northeast Quarter; thence North along the East line of the Southeast Quarter of the Northeast Quarter, a distance of 334.19 feet to the place of BEGINNING.

PARCEL NUMBER THREE

The Northeast Quarter (except the North 20.45 acres of said Quarter and lying West of the land owned by the Forest Preserve District of Cook County) of the Southwest Quarter (except the East 10 acres of the Northeast Quarter of the Southwest Quarter) of Section 35, Township 40 North, Range 12, East of the Third Principal Meridian;

PARCEL NUMBER FOUR

That part of the North half (except the East 460 feet thereof) of the Southeast Quarter of the Southwest Quarter of Section 35; Township 40 North, Range 12, East of the Third Principal Meridian lying North of a line, said line being located 443.0

feet North of and Parallel to the South line of the North half of the Southeast Quarter of the Southwest Quarter;

PARCEL NUMBER FIVE

The West 80.0 feet of the North 80.0 feet of the East 540 feet of that part of the North half of the Southeast Quarter of the Southwest Quarter of Section 35, Township 40 North, Range 12, East of the Third Principal Meridian lying South of a line, said line being located 443 feet North of and parallel to the South line of the North half of the Southeast Quarter of the Southwest Quarter;

PARCEL NUMBER SIX

The North 80.0 feet of the East 460 feet of that part of the North half of the Southeast Quarter of the Southwest Quarter of Section 35, Township 40 North, Range 12 East of the Third Principal Meridian lying South of a line being located 443 feet North of and parallel to the South Line of the North Half of the Southeast Quarter of the Southwest Quarter.

Section 4. The Village Attorney of the Village of River Grove is hereby authorized and directed to record with the Recorder of Deeds of Cook County, Illinois a certified copy of the Ordinance together with the legal description and an accurate map of the territory annexed.

RESOLUTION TO ANNEX COMMUNITY COLLEGE DISTRICT 504, TRITON COLLEGE, TO THE VILLAGE OF RIVER GROVE

WHEREAS, since the inception of Community College District 504, Triton College, (hereinafter referred to as the "College"), the College has been considered to be within the Village of River Grove, (hereinafter referred to as the "Village"); and

WHEREAS, it is in the best interests of both the College and the Village that the College be a part of the Village; and

WHEREAS, for many years, the Village has provided police, water, fire, health, and safety support to the College; and

WHEREAS, a recent action by the Court of Cook County necessitated the need for clarification of the relationship between the Village and the College;

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF COMMUNITY COLLEGE DISTRICT 504 (TRITON COLLEGE), AS FOLLOWS:

1. That it is in the best interests of Triton College and the Village of River Grove that the College be annexed to the Village.
2. That the College approve a Petition for Annexation, a copy of which is attached hereto and made a part of this Resolution and petition to court to approve such action.
3. That the Administration be authorized to take all necessary steps to effectuate the intent of this Resolution.
4. That this Resolution shall be in full force and effect from and after its passage.

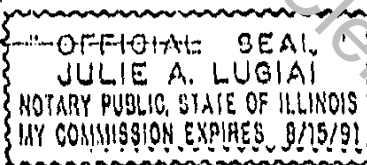
