## THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED):

- 1. Grantors shall (1) promptly repair, restore or rebuild any buildings or improvements now or bereafter on the premises which may become damaged or be destroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanic acrother liens are claims for lien not expressly subordinated to the lien hereof; (2) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory avidence of the discharge of such prior lien to Trustee or to Beneficiary; (4) complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (5) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (6) make no material alterations in said premises except as required by law or municipal ordinance.
- 2. Grantors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when, and shall, upon written request, furnish to Trosteeur to Beneficiary duplicate receipts therefor. In prevent default be reunder Grantors shall pay in full under protest, in the manner provided by statute, tax or assessment which Grantor may desire to contest.
- 3. Grantors shall keep all buildings and improvements now or bereafter situated on said premises insured against loss or daminge by fire, lightning or windstorm under policies providing for payment by the Insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the Beneficiary, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the Beneficiary, such rights to be evidenced by the standard montage clause to be not actached to each policy, and shall deliver all policies, including additional and renewal policies, to Beneficiary, and in case of insurance about to expire, shall deliver renewal policies not less than ten days print to the respective dates of
- 4. In case of default therein, Trustee or Beneficiary may, but need not, make any popos, at or perform any act hereinbefore requirest of Grantors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compressinise or settle any tax lieu or other prior lieu or title or claim thereof, or redeem from any tax sale or forfeiture affecting said premises or context any tax or assessment. The Trustee or Beneficiary bereby accured making any payment bereby authorized relating to taxes or assessments, may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, furfeiture, tax lien or title or claim thereof.
- 6. Grantors shall pay each item of indebtedness berein mentioned, both principal and interest, when due according to the terms bereaf.
