Grantor reserves to itself the right to grant to subsequent grantees of Units in the Condominium all of the rights and easements set forth in the Declaration and Umbrella Declaration for the benefit of the remaining real estate from time to time subject to the Declaration.

PARCEL 2: Non-exclusive easements for the benefit of parcel 1 as set forth and established by the Umbrella Declaration for the Lithuanian World Center recorded November 16, 1990, as document number 90561900, for ingress, egress, parking and structural support of the Lithuanian World Center Residential Condominium Building.
