URDINANCE #319.91

AN ORDINANCE ANNEXING THE PARK DISTRICT OF OAK FOREST, COOK COUNTY, ILLINGIS, PROPERTY WITHIN THE CITY OF OAK FOREST NOT PREVIOUSLY IN SAID PARK DISTRICT, WHICH PROPERTY IS DESCRISED IN THIS ORDINANCE AND LIES WHOLLY WITHIN THE COUNTY OF COOK AND STATE OF ILLINOIS

WHENEAS, Section 3:10 of Chaper 105 of the Illinois Revised Statums of 1965 provides that a Park District may annex by Ordinance all that territory within a City or Village in which said Park District operates; and

WHEREAS, the Commissioners of the Cak Forest Park District, Cook County, Illinois, have considered the question of the annexation of the territory hereinaster described and have determined that said territory is within the City of Oak Forest, Cook County, Illinois, and is contiguous to the territory of the Oak Forest Park District of Cook County, Illinois, and that the residents thereof currently use the facilities of said Park District and will in the future use and need additional facilities in such areas for recreation and park purposes: and

WHEREAS, it is to the best interests of all of the residents of said Park District and to be in the best interests of the residents, the voters and owners of the territory hereinsfter described to become a part of the Oak Forest Park District.

NOW THEREFORE, BE IT ORDAINED BY THE COMMISSIONERS OF THE DAK FOREST PARK DISTRICT:

Section 1. That the territory horeinafter described, said territory described in this Ordinance, and specifically by reference made a part hereof, which said territory being contiguous to the territory of the Oak Forest Park District of Cook County, Illinois, and not within said Park District, or any other Park District, and within the provisions of said Chapter 105, Section 3-10 of the Illinois Revised Statues of 1965 be and the same is hereby annexed to the Oak Forest Park District, Cook County, Illinois, in accordance with the provisions of said Chapter 105, Section 3-10 of the Revised Statutes of Illinois. The territory hereby annexed, as shown by the shaded areas on the maps hereto attached, which are made a part of this Ordinance, is known and described as follows to wit:

OF BLOCK 13 (EXCEPT THAT PART THEREOF LYING SOUTHEASTERLY OF A LINE WHICH INTERSECTS THE WEST LINE OF SAID BLOCK 13, 435.00 FEET FROM THE NORTHWEST CORNER OF SAID BLOCK 13 AND INTERSECTS THE NORTH LINE OF SAID BLOCK 13, 455.00 FEET FROM THE NORTHWEST CURNER OF SAID BLOCK 13) IN ARTHUR T. MC INTOSH & CO'S SOUTHTOWN FARMS UNIT NO. 3, A SUBDIVISION IN FRACTIONAL SECTION 28, NORTH, AND SOUTH OF THE INDIAN BOUNDARY LINE IN TOWNSHIP 36 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

and which said truct of land above described and in the attached description is intended to be all in the territory within the City Limits of the City of Oak Forest not previously included within the Oak Forest Park District.

Section 2. This ordinance shall take effect and be in full force and effect from and after its passage and approval according to law and after filing of a certified copy of this Ordinance and the map attached hereto, in the Office of the Recorder of loods and Clerk of the Circuit Court of Cook County, Illinois, as provided by law.
