AN ORDINANCE ANNEXING THE PARK DISTRICT OF GAR FOREST, COOK COUNTY, ILLINOIS, PROPERTY WITHIN THE CITY OF GAR FOREST NOT PREVIOUSLY IN SAID PARK DISTRICT, WHICH PROPERTY IS DESCRIBED IN THIS ORDINANCE AND LIES WHOLLY WITHIN THE COUNTY OF COOK AND STATE OF ILLINOIS

WHERMAD, Section 0.10 of Chaper 105 of the Illinoir Revised States of 1965 provides that a Park District may annex by Ordinance all that territory within a City or Village in Which said Park District operators and


WHEREAS, the Commissioners of the Uak Forest Park Pastrict, Cook County Tilanois, have considered the question of the territory hereinafter described and have determined that and territory is within the City of Oak Forest, Cook County, Illinois, and is contaquous to the territory of the Oak Forest Park District of Cook County, Illinois, and that the residents thereof currently use the facilities of said Park District and will in the future use and need additional facilities in such areas for recreation and park purposes; and

WHEREAS, it is to the best witerests of all of the residents of said Park District and to be in the best interests of the residents, the voters and owners of the territory hereinafter described to become a part of the Oak Forest Park District.

NOW THEREFORE, BE IT ORDAINED BY THE COMATISIONERS OF THE OAK FOREST PARK DISTRICT:

Section 1. That the territory hereinalter described, said territory described in this Ordinance, and specifically by reference made a part hereof, which said territory oring contiguous to the territory of the Oak Forest Park District of Cook County, Illinois, and not within said Park District, or any other Park District, and within the provisions of said Chapter 105, Section 3-10 of the Illinois Revised Statuss of 1985 be and the same is hereby annexed to the Oak Forest Park District, Cook County, Illinois, in accordance with the provisions of said Chapter 105, Section 3-10 of the Revised Statutes of Illinois. The territory hereby annexed, as shown by the shaded areas on the maps hereto attached, which are made a part of this Ordinance, is known and described as follows to wit:

LOT 2 IN JUSTAMERE SUBDIVISION OF THE NORTH 540 FEET OF THE SOUTH 900 FEET OF THE CAST 10 RODS OF THE WEST HALF OF THE NORTHEAST QUARTER OF SECTION 7, TOWNSHIP D6 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, ALSO THE NORTH 540 FEET OF THE SOUTH 900 FEET OF THE WEST 198 FEET OF THE EAST HALF OF THE NORTHEAST QUARTER OF SECTION 7, TOWNSHIP 36 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, ALSO THE EAST THREE (3) FEET OF THE WEST FIVE (5) RODS OF THE LAST 15 RODS OF THE NORTH 540 FEET OF THE SOUTH 900 FEET OF THE WEST HALF OF THE NORTHEAST QUARTER OF SECTION 7, TOWNSHIP 35 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.
