That the bank convenants and consents that the lien of its Mortgage document number 90533797 shall be subject and subordinate in lien to the lien of The First National Bank of Chicago Mortgage dated August 16th, 1991 reflecting and securing the loar made by the Bank to Sidney G. Saltz, Trustee of The Sidney G. Saltz Declaration of Trust dated September 19, 1990 in the amount of One Hindred Seventy Five Thousand no/100 (175,000.00) Dollars, and recorded in Cook County, Illinois as document number 11431510, and to all renewals, extensions or replacements of said Mortgage; and
- 2. That this Agreement shall be binding upon and shall insure to the benefit of the Bank, their successors and assigns.
