### "23. Right of Repurchase.

- In the event Purchaser (Grantee) desires to sell or proposes to close the sale of the Unit Ownership (Unit No. \_\_4802 in 100 East Huron Street Condominium, together with its undivided percentage interest in the common elements; within one (1) year after the Closing Date, Purchaser hereby grants Seller (Grantor) a right to repurchase the Property on the terms and conditions hereing ther set forth. Purchaser shall notify Seller in writing not less than forty live (45) days prior to the closing of such a proposed sale, which notice shall contain the name and address of the proposed purchaser and shall contain a copy of the proposed contract of sale including the terms and conditions of sale. Seller shall have the right to repurchase the Property, which right shall be exercised by written notice to Purchaser within thirty (30) days after receipt of said notice from Purchaser, on the following terms: (i) the price shall be the Repurchase Price (as hereinafter defined) plus or minus prorations of general real estate taxes, prepaid insurance premiums, utility charges, monthly assessments and other similar proratable items; (ii) Purchaser shall convey good and marketable title to the Unit Ownership by special warrant, deed to Seller or its designee, and the Personal Property by bill of sale with warranties of title, subject only to those permitted exceptions (excluding acts of Purchaser) existing at closing and any acts of Seller; (iii) closing of the repurchase shall be effected through an escrow similar to that described in Paragraph 5(b) hereof; (iv) Purchaser shall bear all costs of the escrow and title insurance in the amount of the Repurchase Price; and (v) and Illinois and Cook County transfer taxes shall be paid by Purchaser, and any city of Chicago real estate transaction tax shall be paid by Seller. The Repurchase Price shall be the Purchase Price set forth in Paragraph 2 hereof plus the cost of any improvements or betterments made by Purchaser to the Purchased Unit after the Closing Date, which costs shall be established by copies of paid bills delivered to Seller at the time of giving of Purchaser's forty five (45) day notice to Seller. If Seller notifies Purchaser within said thirty (30) day period of its election to repurchase the Property, then such reputchase shall be closed and possession delivered to Seller within thirty (30) days after the giving of Seller's notice of such election. In the event of Seller's repurchase of the Property as provided herein, Purchaser agrees to reconvey the Purchased Unit and Personal Property to Seller in the same physical condition as at closing, except for ordinary wear and tear and improvements or betterments made by Purchaser to the Purchased Unit.
