MORTGAGE

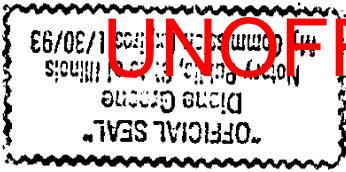

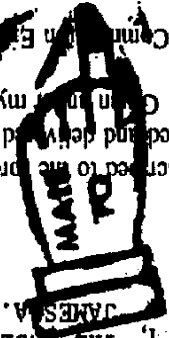
