

- (a) To purchase or otherwise acquire, by issuance of its own shares or obligations or otherwise, to sell, pledge or otherwise dispose of, and generally to trade and deal in and with, investments, securities and obligations of every class and description, including, but not limited to, all manner of shares, stocks, mortgages, bonds and notes of any person, firm, government or corporation, domestic or foreign, and to exercise any and all rights, powers and privileges of individual ownership of all such investments, securities and obligations, including the right, if any to vote thereon, and to do any acts and things designed to protect or enhance the value thereof.
- (b) To lease, purchase or otherwise acquire, to own, use and develop, to sell, convey, exchange, lease and encumber, and generally to trade and deal in and with lands, buildings and other real property, and any and all interests and rights therein or appurtenant thereto.
- (c) To engage in construction work of every kind and description, to make estimates for itself and others, to bid upon, enter into and carry out contracts and arrangements for the building and construction of works of any and every nature, and to do a general contracting business.
