WHEREAS, said note is due and payable and the parties wish to extend the maturity date of the note;

NOW, THEREFORE, the parties hereto agree to extend the maturity date of the note and mortgage to August 10, 1992. The parties further agree that the outstanding principal balance will bear interest at one half of one percent (.50%) higher than the Harris Bank Hinsdale, National Association prime rate of interest as set from time to time. The prime rate of interest as of the date of this Agreement is eight and one half percent (8.50%).

In all other respects, the parties hereto reconfirm and ratify the provisions of the mortgage and note, and previous loan modification agreements.
