NOW, THEREFORE, it is agreed by the parties hereto that the Note or other Obligation evidencing said indebtedness shall be and is hereby modified to provide for an interest rate as

Beginning July 9, 1991, interest shall accrue on the unpaid principal balance at that of 8.75% per annum fixed. Beginning July 9, 1992 and each July 9th during the term hereof, the rate shall acjust to 2.50% above the rate of 8.75% per annum fixed. charged on monies deposited with Community Bank of Edgewater under the Community Loan Program from the State of Illinois fixed for the next year. In the event that monies deposited by the State of Illinois are withdrawn during the term of this loan, the rate shall be adjusted to 10.25% fixed for The monthly payment of principal and the remaining term. interest may be adjusted on the Interest Rate change date to recognize an increase in the Interest Rate.

In all other respects said Note or other obligation and said trust deed shall remain unchanged and be in full force and effect.
