MEMORANDUM OF REAL ESTATE SALE CONTRACT

This Memorandum of Real Estate Sale Contract (the "Memorandum") is a memorandum of the terms of that certain Real Estate Sale Contract dated August 10, 1991 and Rider and Letter Agreement relating thereto (collectively the "Contract") by and between Merrick M. Wlfman and Therese L. Wareham, as purchasers (collectively "Purchaser"), and Charles L. Page and Pamela H. In the event of a conflict between the Contract and this Memorandum, the Contract shall control.
