EXTENSION AGREEMENT

THIS EXTENSION AGREEMENT, made this 10th day of September, 1991, by and between HARRIS TRUST AND SAVINGS BANK ("LENDER"), the owner and holder of the Note hereinafter described, and Peter Kopsaftis and Frances Kopsaftis, his wife, maker of said Note ("BORROWER"), WITNESSETH:

1. The parties hereby agree to extend the time of payment of the indebtedness evidenced by the Note dated October 24, 1990, in original amount of \$554,300.00, (the "Note"), secured by a mortgage or trust deed in the nature of a mortgage recorded December 20, 1990 in the office of the Recorder of Cook County, Illinois as document number 90-614095 conveying to HARRIS TRUST AND SAVINGS BANK certain real estate in Cook County, Illinois described as follows:

LOT 1 IN SUNSET SUBDIVISION, A RESUBDIVISION OF TRACT 8 IN ARTHUR T. MCINTOSH AND COMPANY'S RAMBOW HILLS, A SUBDIVISION OF PART OF SECTION 16, TOWNSHIP 42 NORTH, PANGE 9, LAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED NOVEMBER 21, 1989 AS DOCUMENT NO. 89556201, IN COOK COUNTY, ILLINOIS.

2. The amount remaining unpaid on the Note is \$554,300.00.

- 3. Said remaining indebtedness shall be paid on or before December 31, 1991, (the "extended maturity date") and the Borrower in consideration of such extension promises and agree to pay the entire indebtedness secured by said Mortgage or Trust Deed as and when therein provided, as hereby extended, and to pay interest thereon until maturity as hereby extended at the rate provided in said Note.
- 4. If any part of said in lebtedness or interest thereon be not paid at the extended maturity date, or if refault in the performance or any other covenant of the Borrower shall occur under the Morgage or Trust Deed, or if any other default shall occur under the Noterin Mortgage or Trust Deed, the entire principal sum secured by said Mortgage of Trust Deed, together with the then accrued interest thereon, shall, without notice, at the option of the holder or holders of the Note, become and be due and payable, in the same manner as if said extension had not been granted.
- 5. This agreement is supplementary to said Mortgage or Trust Deed. All the provisions thereof and of the Note, including the right to declare principal and accrued interest due for any cause specified in said Mortgage or Trust Deed or Note, shall remain in full force and affect except as herein expressly modified, it being the express intent of the parties that the indebtedness heretofore described is not discharged but merely extended pursuant to the terms of this agreement. The provisions of this agreement shall inure to the benefit of any holder of said Note and shall bind the heirs, personal representatives and assigns of the Borrower. The Borrower here'y waives and releases all rights and benefits under and by virtue of the Homesterd Exemption Laws of the State of Illinois with respect to said real estate. If the Borrower consists of two or more persons, their liability hereunder shall be joint and several.
