KNOW ALL MEN BY THESE PRESENTS that BAIRD & WARNER, INC., an Illinois corporation, having its principal place of business in the City of Chicago, County of Cook, State of Illinois ("Assignor") for good, valuable and sufficient consideration paid by AID ASSOCIATION FOR LUTHERANS, a corporation organized and existing under the laws of the State of Wisconsin ("Aid Association") has by the provisions of Security Agreement and Assignment of Collateral Documents and Deposits of even date herewith ("Assignment of Collateral Documents") collaterally sold, transferred, assigned and set over to Aid Association all right, title and interest of Assignor in and to the following:

- a). mortgage dated the 16th day of March, 1973 made by Garfield State Trust and Savings Bank, as Trustee, D/T/A*, recorded in the Recorder's Office of Cook County, Illinois ("Recorder's Office") as Document No. 2225074 ("Mortgage"), in favor of CLYDE FEDERAL SAVINGS ASSOCIATION (the receiver of which is RESOLUTION TRUST CORPORATION, a corporation organized and existing pursuant to the laws of the United States of America) encumbering the land and improvements commonly identified and legally described on Exhibit "A" attached hereto and made a part hereof;
* dated February 24, 1972 and known as Trust No. 72-2-2.
- b). assignment of leases and rents dated the 16th day of March, 1973, recorded in the Recorder's Office as Document No. 2225075;
- c). the indebtedness evidenced by note dated March 16, 1973 in the amount of \$50,000.00, payable to the order of CLYDE FEDERAL SAVINGS ASSOCIATION and endorsed to the order of the Assignor and the indebtedness evidenced thereby ("Note"); and
- d). security agreement, financing statements and other documents and instruments executed and delivered as security for the Note.

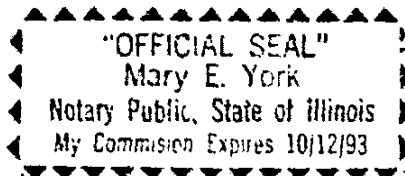
