**AN ORDINANCE ANNEXING
LAND TO THE ROBBINS PARK DISTRICT
(SOUTH OF 140TH STREET)**

WHEREAS, the Robbins Park District is a Park District organized under authority extended to Park Districts under the Illinois Park District Code, Illinois Revised Statutes, Chapter 105, Section 1-1 et seq. (1989); and

WHEREAS, the Robbins Park District may by ordinance, in its discretion, annex territory adjoining its boundaries or separated therefrom only by a roadway or highway if a petition is received signed by a majority of the legal voters residing in and a majority of owners of the territory, Illinois Revised Statutes, Chapter 105, Section 3-1 (1989); and

WHEREAS, the majority of owners of the territory described in Exhibit "A" and depicted in Exhibit "B" herewith, there being no legal voters residing in the territory, have petitioned for annexation to the Robbins Park District.

NOW, THEREFORE, Be It Ordained by the Board of Park Commissioners of the Robbins Park District, Cook County, Illinois that:

Section 1: The territory described in Exhibit "A" and depicted on Exhibit "B," both of which are attached herewith and made a part of this ordinance, shall be, and hereby is, annexed and made a part of the Robbins Park District.

Section 2: The Secretary of the Robbins Park District is hereby directed and authorized to prepare a certified copy of this ordinance and to file the same with the office of the Cook County Clerk and record it with Cook County Recorder.

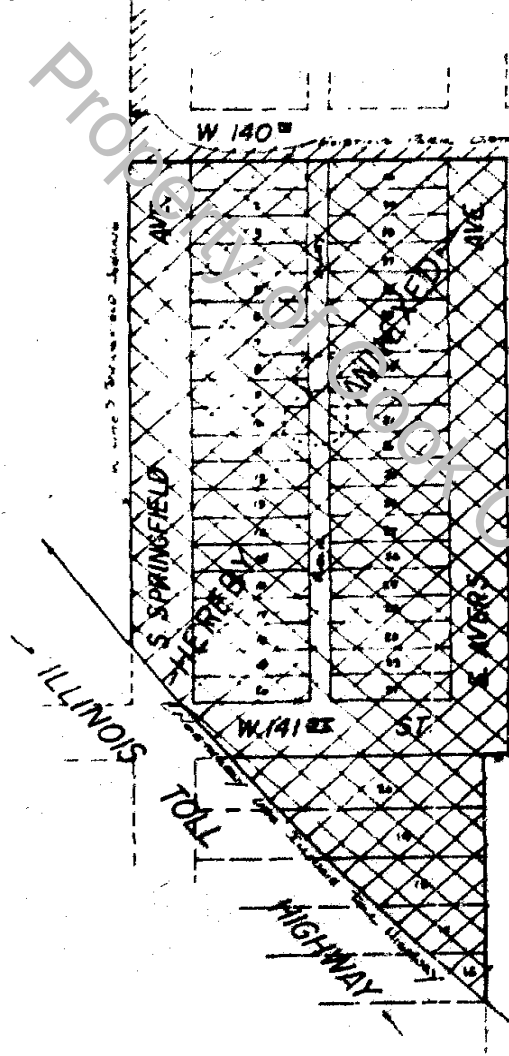
