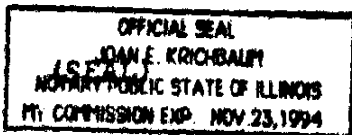
WHEREAS, the aforesaid charges, together with additional fees and related expenses incurred by said Village have been paid in full;
