NOW, THEREFORE ARTICLE 5, SECTION 9 of the Declaration, as amended, is hereby further amended as follows:

"Section 9. Encroachments. If any portion of the common elements encroaches upon any Unit, or if any Unit encroaches upon any portion of the Common Elements or any other Unit as a result of construction, repair, reconstruction, settlement or shifting of any building, or by reason of the design thereof, a valid mutual easement shall exist in favor of the owners of the Common Elements and the respective Unit Owners involved to the extent of the encroachment, so long as all or part of the building shall remain standing. A valid easement shall not exist in favor of any Unit Owner who creates an encroachment by his intentional, willful or negligent conduct or that of his agent."
