4. The claimant has performed all that was required to be done by it under said oral contract and has completed furnishing labor and material to the value of \$15,763.48.

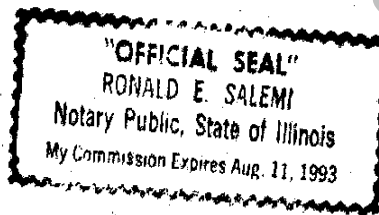
