This Memorandum of Termination of Lease ("Memorandum") is made as of this 25th day of September, 1991, by and between the Medical Center Commission, a body politic and corporate of the State of Illinois, as "Landlord," and the City of Chicago, an Illinois municipal corporation, is "Fenant," both having offices in Chicago, Illinois.

- Lease, on May 5, 1983, with Amgen, Inc. (the "Prior Lessee"), whereby Landlord leased to the Prior Lessee certain premises identified in said lease as Parcel A and Parcel B, including all improvements constructed by Assignor on such parcels (the 'Premises'). A legal description of the Premises is set forth in Exhibit A attached hereto. The lease was amended by a First Amendment, dated September 16, 1983, by a Second Amendment, dated November 15, 1963, by an initial Third Amendment, dated December 15, 1983, and by an additional Third Amendment, dated July 26, 1986) (collectively, the "Lease"). The Prior Lessee's interest in the Lease has been assigned to Tenant.
- 2. This Memorandum is executed and recorded solely for the purpose of giving record notice of the termination of said Lease by Landlord and Tenant. This Memorandum creates no rights or obligations.
- 3. This Memorandum may be executed in counterparts, each of which shall constitute an original and all of which shall be deemed to be one and the same instrument.

EXHIBIT "A" TO MEMORANDUM OF TERMINATION OF LEASE

Medical Center Commission, Landlord

Legal Description of the Premises

PARCEL "A"

That part of Block 6 in Flournoy's Resubdivision of Jones and Patrick's Addition to Chicago in the East 1/2 of the Southwest 1/4 of Section 18, Township 39 North, Range 14 East of the Third Principal Meridian described as follows: Beginning at the intersection of the South line of West Lexington Street and the West line of South Hoyne Avenue; thence South 00° - 05' - 55" West along the West line of said South Hoyne Avenue, a distance of 118.91 feet to the Northwesterly line of West Bowler Street; thence South 42° - 56' - 43" West along the Northwesterly line of said West Bowler Street, a distance of 200.12 feet to the North line of West Polk Street, thence North 89° - 54' - 51" West along the North line of said West Polk Street, a distance of 249.17 feet to the Southwest corner of Lot 30 in said Block 6; thence North 90' - 00' - 00" East along the West line of said Lot 30 and its Northward extension and along the West line of Lot 11 in said Block 6, a distance of 265.98 feet to the Northwest corner of said Lot 11, said Northwest corner of Lot 11 being on the South line of said West Lexington Street; thence South 89° - 51' - 32" East along the South line of said West Lexington Street, a distance of 385.72 feet to the point of beginning.

PARCEL "B"

Lot 30 in Block 5 in Flournoy's Resubdivision of Jones and Patrick's Addition to Chicago in the East 1/2 of the Southwest 1/4 of Section 18, Township 39 North, Range 14 East of the Third Principal Meridian, also that part of West Bowler Street lying West of the West line of South Hoyne Avenue extended Southward and lying North of the North line of West Polk Street.
