- 1. ASSIGNMENT. To further secure the payment of the promissory note or credit agreement described above (the "Note") and the performance of the Mortgage or Deed of Trust which concumbers the real property described in Schedule A on the reverse side of this Agreement, Grantor absolutely assigns to Lender all of Grantor's interes in the leases and tenancy agreements (the "Leases") now or hereafter executed which relate to the real property and any improvements located thereon (the "F emises").     - Refrain from discounting any future rents or executing any future assignment of the Leases or collect any rents in advance without the written ь. consent of Lender.
    - Perform all necessary steps to maintain the security of the Leases for the benefit of Lender including, if requested, the periodic submission to Lender of reports and accounting information relating to the receipt of rental payments.

    - Execute and deliver, at the request of Lender, any assurances and assignments with respect to the Leases as Lender may periodically require.
  - REPRESENTATIONS OF GRANTOR. Grantor represents and wa rants to Lender that:

    - The tenants under the Leases are current in all rent payments and are not in default under the terms of any of the Leases.

      Each of the Leases is valid and enforceable according to its terms, and there are no claims or defenses presently existing which could be b. asserted by any tenant under the Leases against Grantor or any منازراتك of Grantor.
    - No rents or security deposits under any of the Leases have previous y been assigned by Grantor to any party other than Lender. Grantor has not accepted, and will not accept, rent in excess of one mouth in advance under any of the Leases.

    - Grantor has the power and authority to execute this Assignment.
    - Grantor has not performed any act or executed any instrument which might prevent Lender from collecting rents and taking any other action under this Assignment
- 5. GRANTOR MAY RECEIVE RENTS. As long as Grantor or Borrower is not in default under any obligation to Lender or under the Mortgage or Deed of Trust or this Agreement, Grantor may collect all rents and profits from the Leases when due and may use such proceeds in Grantor's business operations. However, Lender may at any time require Grantor to deposit all rents and profits into an account maint fined by Grantor or Lender at Lender's institution.
- 6. DEFAULT AND REMEDIES. Upon default in the payment of any indebtedness of Borrower of Linder or in the performance of any obligation or covenant of Borrower or Grantor in this Assignment or any other agreement, Lender may at its cation, take possession of the real property and the improvements and have, hold, manage, lease and operate the Premises on terms and for a period of time that Lender deems proper. Lender may proceed improvements and have, hold, manage, lease and operate the Premises on terms and for a period of time that Lender deems proper. Lender may proceed to collect and receive all rents, income and profits from the Premises, and Lender shall have full power to periodically make alterations, renovations, repairs or replacements to the Premises as Lender may deem proper. Lender may apply all rents, income and profits to the payment of the cost of such alterations, renovations, repairs and replacements and any expenses incident to taking and retaining possession of the real property and the management and operation of the real property. Lender may keep the Premises properly insured and may discharge any taxes, charges, claims, assessments and other tiens which may accrue. The expense and cost of these actions may be paid from the rents, issues, income and profits received, and any unpaid amounts shall be secured by the Note and Mortgage or Deed of Trust. These amounts, together with attorneys' fees and Charges, shall become part of the indebtedness secured by the Mortgage or Deed of Trust and this Assignment.

- 7. POWER OF ATTORNEY. The receipt by Lender of any rents, income or profits under this Assignment after institution of foreclosure proceedings under the Mortgage or Deed of Trust shall not cure any default or affect such proceedings or sale which may be held as a result of such proceedings.
- 8. BENEFICIAL INTEREST. Lender shall not be obligated to perform or discharge any obligation, duty or liability under the Leases by reason of this Assignment. Grantor hereby agrees to indemnify Lender and to hold Lender harmless from any and all liability, loss or damage which Lender may incur under the Leases by reason of this Assignment and from any and all claims and demands whatsoever which may be asserted against Lender by reason of any alleged obligations or undertakings on Lender's part to perform or discharge any of the terms or agreements contained in the Leases. Should Lender incur any liability, loss or damage under the Leases or under, or by reason of this Assignment, or in the defense of any such claims or demands, the amount of such loss, including costs, expenses and reasonable attorneys' fees, shall be secured by the Note which this Assignment secures. - 10. INDEPENDENT RIGHTS.   - c. This Agreement shall be binding upon and inure in the benefit of Grantor and Lender and their respective successors, assigns, trustees, receivers, administrators, personal representatives, legatives, and devisees.
