- A. Assignor has executed and delivered to Assignee a Note of even date herewith (the "Note"), in the principal sum of ONE MILLION FOUR HUNDRED

  THOUSAND AND NO/100 DOLLARS (\$1,400,000.00). The Note is secured by a Mortgage (the "Mortgage") on certain property (the "Property") in Chicago, Illinois, legally described on Exhibit A attached hereto and made a part hereof, and also by certain Additional Collateral as defined and described in the Note;
- B. Beneficiary is the sole beneficiary and hower of the entire power of direction under the Trust Agreement creating Trustee; and

- 1. Assignor does hereby empower Assignee, its agents or attorneys, to collect, sue for, settle, compromise and give acquittances for all of the rents that may become due under the Leases and avail i self of and pursue all remedies for the enforcement of the Leases and Assignor's rights in and under the Leases as Assignor might have pursued but for this Assignment; subject, however, to the provisions contained in Paragraph 7 hereof.

- (b) that if the Leases provide for the abatement of rent during repair of the demised premises by reason of fire or other casualty, Assignor shall furnish rental insurance to Assignee, the policies to be in amount and form and written by such insurance companies as shall be satisfactory to Assignee;
- (c) not to terminate, modify or amend the Leases or any of the terms thereof, or grant any concessions in connection therewith, either orally or in writing, or to accept a surrender thereof without the written consent of Assignee (such consent not to be unreasonably withheld or delayed) and that any attempted termination, modification or amendment of the Leases without such written consent shall be null and void;
- (d) not to collect any of the rent, income and profits arising or account under the Leases more than one month in advance of the time when the same become due under the terms thereof;

- (i) that none of the rights or remedies of Assignee under the Mortgage shall be delayed or in any way prejudiced by this Assignment;
- (j) that notwithstanding any variation of the terms of the Mortgage or any extension of time for payment thereunder or any release of part or parts of the land conveyed thereunder, the Leases and benefits hereby assigned shall continue as additional security in accordance with the terms hereof;
- (k) not to alter, modify or change the terms of any guarantees of the Lases or cancel or terminate such guarantees without the prior written consent of Assignee (such consent not to be unreasonably withheld or delayed);
- (I) not to consent to any assignments of the Leases, or any subletting thereunder, whether of not in accordance with their terms, without the prior written consent of Assigner (such consent not to be unreasonably withheld or delayed); and


