### TERMINATION OF LEASE AGREEMENT

THIS AGREEMENT, is made this 30th day of September, 1991, by and between VILLAGE OF MCCOOK, ILLINOIS, an Illinois municipal corporation, hereinafter designated "Landlord", and CROUSE CARLAGE COMPANY, an Iowa corporation, hereinafter designated "Tenant."

The Leave shall terminate on September 30, 1991 (the "Termination Date"), in the name manner and with the same effect as if that date had been originally fixed in the Lease for the expiration of the term conditioned on the performance by the parties of the provisions of this Agreement.
