MMEREAS, the Director by Order Number 90-3080, dated December 13, 1990, appointed RTC as Conservator for the Association;

INVEREAS, Pursuant to Section 21(b)(4) of the Federal Home Loan Bank Act, as amended by Section 501 of FIRREA, among other powers, the RTC as conservator may exercise any authority granted to the FDIC under Sections 11,12, and 13 of the Federal Deposit Insurance Actions amended by Section 212, 213, 214, 216, and 217 of FIRREA;

THE REAS, the RTC / conservator has determined that it is appropriate and Necessary pursuant to Section 11(d)(2)(G) of the Faderal Deposit Insurance Act, to transfer certain assets of the Association to Phoenix Mortgage Corporation having its principal business in Little Cock, Arkenses.

WHEREAS, The RTC, as convenience of OLYMPIC FEDERAL SAVINGS ASSOCIATION, SUCCESSOR TO Olympic Federal, and Phoenia Hortgage Corporation, the Purchaser, on July 23, 1991, executed a Mortgage Loan Sale Agreement pursuant to which assets of the Association were transferred to the 'nuchaser; and
