AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF LANSING, COOK COUNTY, ILLINOIS

WHEREAS, a Petition for Annexation, which is attached hereto and made a part hereof, of the property legally described in Exhibit A, has been filed with the Village Clerk, as provided in Chapter 24, Section 7-1-1, et. seq., of the Illinois Revised Statutes; and

WHEREAS, the Illinois Revised Statutes provide that property which is not within the corporate limits of any municipality, but which is contiguous to a municipality, may be annexed on written petition signed by the owners of record and fifty-one percent (51%) of the electors residing in such territory; and

WHEREAS, the owners of record, and all of the electors residing thereon, have executed their written petition for annexation in accordance with the applicable statutes;

NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LANSING, Cook County, Illinois, in the exercise of its home rule powers as follows:

SECTION 1: That the petition heretofore filed by DONALD DEJONG and CINDI DEJONG, to annex the property described in Exhibit A, attached hereto and the same is hereby granted.

SECTION 2: That the Village Clerk is directed to record a certified copy of this Ordinance, together with an accurate map of the annexed territory, in the Office of the Recorder of Deeds of Cook County, Illinois.
