That at the special instance and request of said Contractor, the claimant furnished extra and additional labor and materials on said premises of the value of \$6,247.50.

That on July 15, 1991, the lien claimant completed all work required under said contract and extras.

The Owner is entitled to credits for payments in the amount \$36,990.00, leaving due, unpaid and owing to the claimant the sum of \$11,257.50 for which, with interest, the claimant claims a lien on said land and improvements and on the monies or other considerations due or to become due from the Owner under said contract against said Contractor and Owner.

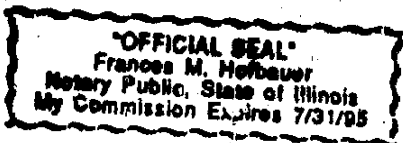
