4. Barring an emergency, drop off and pick up shall be within 15 minutes of the scheduled time and ~~no later than~~

5. Respondent shall not exit his vehicle for any reason whatsoever at pick up or drop off. He shall only pull up to the curb in front of the petitioner's home for pick up and drop off.

6. Respondent shall not telephone the Petitioner for any reason other than for an emergency concerning the child's health or to report emergency regarding pick up.


