The Claimant, NATIONAL ENTERPRISES, INC. through its National Building Systems Division, having offices at 4421 Cox Road, Building D, Glen Allen, Virginia, 23060, (herein called the "Subcontractor") hereby files a claim for lien against The Chicago Housing Authority, c/o The Habitat Co., Receiver, 405 North Wabash, Chicago, Illinois 60611 (herein called the "Owner").

The Owner owns the land in Cook County, Illinois (herein "the Property") described on Exhibit A attached hereto. The Property is located at 5406 N. Winthrop, Chicago, Illinois. Owner entered into a contract with Powers & Sons Construction Company, Inc. (the "Contractor") to perform certain work on the Property. On May 15, 1990, Contractor executed a written agreement with the Subcontractor pursuant to which Subcontractor was to furnish prefabricated housing units and related component materials for construction on the Property. Subcontractor fully performed its obligations under the subcontract.

The balance due for said materials delivered and installed on the Property by the Subcontractor is \$4,837.00. Notice of this claim has been given by certified mail to Owner in accordance with the Illinois Mechanics' Lien Act.

There is accordingly due, unpaid and owing to the Subcontractor the total sum of \$4,837.00, for which, with interest, the Subcontractor claims a lien on all the Property and improvements described herein.

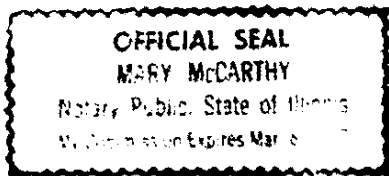
