THIS AGREEMENT is made and entered into as of the 5th day of August, 1991, by and between FIRST OF AMERICA BANK - NORTHEAST ILLINOIS, N.A., formerly known as GOLF MILL STATE BANK ("BANK"), and Girismohai C. Patel and Niranjana G. Patel ("BORROWER").

- A. The BORROWER has heretofore executed a Commercial Installment Note dated July 9, 1991 in the principal amount of One Hundred Eighty Thousand ro(100 (\$180,000.00) ("NOTE") of which the BANK is presently the holder:
- B. The NOTE is secured by a mortgage dated July 9, 1991 and recorded in the Recorders Office of Cook County, Illinois as Document Number 91374451 conveying to certain real estate described in "Exhibit A" attached hereto and by this reference incorporated herein ("REAL ESTATE");
- c. The NOTE is further secured by an Assignment of Rent's bearing even date therewith and recorded in the Recorder's Office of Cook County, Illinois as Document Number 91374452 ("ASSIGNMENT OF RENTS") assigning all the rents and profits from the REAL ESTATE;

- D. The BANK has disbursed to BORROWER the full principal sum evidenced by the NOTE and has received payments of principal and interest from the lien of the hereinabove described Mortgage and Assignment of Rents;
- E. BORRDWER has requested BANK to amend the maturity date for the payment of the hereinabove described NOTE, MORTGAGE and ASSIGNMENT OF RENTS;
- F. BANK hasagreed to amdend the maturity date for the payment of the NOTE provided BORROWER agrees to the following terms and conditions:

NOW THEREFORE, in consideration of the mutual covenants, premises and conditions herein contained and the payment of the sum of TEN and no/100 DOLLARS (\$10.00) the receipt of which is hereby acknowledged, THE PARTIES HERETO AGREE AS FOLLOWS:

- 1. The maturity date for the payment of the NOTE is extended from July 9, 1996 to August 9, 1996.
- 2. It is agreed, as of the date hereof, the unpaid principal balance evidenced by the NOTE is One Hundred Eighty Thousand and no/100 (\$180,000) DOLLARS.



3. In consideration of BANK extending the due date to August 9, 1996, BORROWER agrees that the new interest rate will be 10.25% and monthly payments of principal and interest on the new principal sum outstanding from time to time will be One Thousand Seven Hundred Sixty Six and 96/100.

The repayment of the indebtedness shall be 1 (One) payment of \$717.50 and 59 consecutive installments of \$1,766.96 each, beginning on the 9th day of September, 1991 and continuing on the same day of every month thereafter, with a final payment of all remaining prin cipal and interest due on August 9, 1996.

- 4. In the event a payment is ten (10) or more days past due, a late charge of Five Percent (5%) of the total payment amount or \$25.00, whichever is greater, shall be due and payable.
- 5. The lien of the MORTGAGE and ASSIGNMENT OF RENTS is hereby modified and extended as security for the payment of the NOTE.
- 6. Except as modified herein, the terms covenants, and conditions of the NOTE, MORTGAGE and ASSIGNMENT OF RENTS shall remain unchanged and otherwise in full force and effect. In the event of any inconsistency between the terms of this Agreement and the terms of the NOTE and/or MORTGAGE and ASSIGNMENT OF RENTS the terms herein shall control.
