

5. Hazard or Property Insurance. 



#### RALLOON RIDER

(Condicional Right to Refinance)

THIS BALLOON RIDER is made this 14 day of October , 19 91 , and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Deed to Secure Debt (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure the Borrower's Note to COUNTRYWIDE FUNDING CORPORATION, A NEW YORK CURPORATION (the "Lender") of the same date and covering the property described in the Security Instrument and located at: 5023 NORTH LOWELL CHICAGO, IL 60630-

The interest rate stated on the Note is called the "Note Rate." The date of the Note is called the "Note Date." I understand the Lender may transfer the Note, Security Instrument and this Ride. The Lender or anyone who takes the Note, the Security Instrument and this Rider by transfer and who is entitled to reaciful payments under the Note is called the "Note Holder."

ADDITIONAL COVENANTS. In addition to the covenants and agreements in the Society Instrument, Borrower and Lender further covenant and agree as follows (despite anything to the contained in the Security Instrument or the Note):

#### 1. CONDITIONAL RIGHT TO REFINANCE

#### 3. CALCULATING THE NEW NOTE RATE

The New Note Rate will be a fixed rate of interest equal to the Federal National Mongage Association's required net yield for 30-year fixed rate mortgages subject to a 60-day mandatory delivery commitment, plus one-half of one percentage point (0.5%), rounded to the nearest one-eighth of one percentage point (0.125%) (the "New Note Rate").
