SHORT FORM POWER OF ATTORNEY

FOR PROPERTY

POWER OF ATTORNEY made this 30 day of September, 1991.

I, Jules Markowitz, hereby appoint: Paula Markowitz, as my attorney-in-fact (my "agent") to act for me and in my name (in any way I could act in person) with respect to the following powers, as defined in Section 3-4 of the "Statutory Short Form Power of Attorney for Property Law" (including all amendments), but subject to any limitations on or additions to the specified powers inserted in paragraph 2 or 3 below:
