NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, each of the undersigned agrees as follows:

1. Acknowledgement. Weimarc hereby acknowledges and agrees that the Equipment is owned by Cramlo and is being leased by Cramlo to Olmarc pursuant to the Equipment Lease. The Equipment Lease shall at all times constitute a first claim and lien on the Equipment.

2. Authorization to Cramlo. Each of the undersigned hereby authorizes Cramlo and/or PrivateBank without notice or demand, and without affecting his liability hereunder, from time to time to:

(a) change the amount, time or manner of payment of rent or other sums reserved in the Equipment Lease;

(b) change any of the terms, covenants, conditions or provisions of the Equipment Lease;

(c) amend, modify, change or supplement the Equipment Lease;

(d) assign the Equipment Lease or the rents or other sums payable thereunder;

(e) consent to Olmarc's assignment of the Equipment Lease or to the sublease of all, or any portion, of the Equipment;

(f) take and hold security for the performance of the Equipment Lease; and

(g) apply such security and direct the order or manner of sale thereof as Cramlo, in its discretion, may determine.

3. Personal Property. The Equipment shall at all times be and remain personal property notwithstanding that it, or any part thereof, may now be or hereafter become in any manner affixed or

4. Access and Removal. Cramlo or its assignee may at any time and from time to time, enter upon the premises in which the Equipment is located, or any part thereof, and remove therefrom all or any part of the Equipment.

5. Continuance of Agreement. This agreement shall continue and remain in full force and effect until Cramlo has been paid in full on account of all claims, demands, indebtedness, actions or causes of action of any nature whatsoever which it may now or hereafter have against each of the undersigned on account of, or arising out of, the performance of the Equipment Lease, or until Cramlo completely has removed all of the Equipment from the Real Estate.

6. Binding Effect. This agreement shall be binding on each of the undersigned, his heirs, devisees, personal representatives, successors and assigns; and shall inure to the benefit of Cramlo and PrivateBank and their successors and assigns.

7. Liability. If more than one person executes this agreement, the liability of such persons hereunder is joint and several.

8. Entire Agreement. This Agreement supersedes all agreements previously made between the parties relating to its subject matter. There are no other understandings or agreements between them.
